# **TOP ADVOCACY ITEMS**

Priority	Status
Highlight the Valuable Roles, Duties, and Rights of Local Governments	The biennial operating budget (HB 49) passed the House and is pending before the Senate Finance Committee.  Prior to the budget passed the House, William Murdock submitted written interested party testimony on April 24.  The testimony focused on areas of opportunity and concern in the budget. Promote Energy Efficiency and an Abundant Supply of Safe, Reliable, and Affordable Sources of Energy for our Growing Region	The Ohio House rapidly passed HB 114, which would replace all energy standards/ mandates with goals. The bill is now pending in the Ohio Senate and has yet to receive its first hearing.  Leadership from the Sustainability Advisory Committee (SAC) and Regional Policy Roundtable convened a conference call regarding HB 114 that would revise Ohio's energy standards. The bill was reviewed by the SAC and the Roundtable in April. Staff will continue to track the bill with the idea of possibly taking a position on the bill in the future.
Establish MORPC as Top MPO Resource on Transportation Issues. Advocate for policies and legislation that enhance regional priorities.	Following testimony by William Murdock, the General Assembly finalized and Governor Kasich signed the biennial transportation budget (HB 26). The final version of the bill contains a \$5 discretionary increase for license plate fees for counties as well as additional funding for transit. Many MORPC members were instrumental in helping to lobby for the passage of the final version of the bill.

### Aging

According to unofficial results, the three senior services levies on the May 2 ballot in Ohio all passed with big margins.

#### Ballot Issues

Ohio Attorney General (AG) Mike DeWine rejected the petition for a proposed amendment to the Ohio Constitution which would change Ohio's congressional redistricting process, saying the petition summary omits important information.

### FY18-19 Budget

The House reduced all spending by \$1 billion in FY18 and \$1.5 billion in FY19 while directing about a quarter billion dollars more over two year to schools and anti-addiction efforts in the first round of major changes to Gov. John Kasich's proposed budget. The House Finance Committee accepted the substitute version of HB49 following a morning press conference where Chairman Rep. Ryan Smith (R-Gallipolis) explained the changes alongside House Speaker Cliff Rosenberger (R-Clarksville) and Speaker Pro Tem Kirk Schuring (R- Canton). The House changes give the greatest funding increases to drug treatment, prevention and recovery efforts, with an additional \$170 million allocated. In K-12 education, the House committed about \$80 million in additional funding. The proposal largely jettisons Gov. John Kasich's tax reform proposals, foregoing attempts at a tax cut but eliminating the bottom two brackets of the income tax.

The new House version of the FY18-19 budget bill targets more K-12 funding to help schools with low property wealth, high transportation costs or heavy dependence on power plants as part of their tax base. The substitute version of HB49 (R. Smith), accepted in House Finance Committee, includes a small across-the-board increase in base perpupil funding, raising it from \$6,000 to \$6,020. The bill also raises the cap on how much funding above FY17 levels a school can get, from 5 percent to 5.5 percent. In addition, it changes the multiplier used in the capacity aid calculation for low-wealth districts from 3.5 to 4.0. Plus, the bill exempts the transportation supplement for geographically dispersed districts from funding guarantees.

House Republicans are trying to address the addiction problem in Ohio with initiatives in everything from treatment facilities to child protective services to getting workforce credentials for those in recovery. The plan unveiled in the new version of HB49 (R. Smith) is part of the caucus' Ohio HOPES (heroin, opioid, prevention, education and safety) agenda. House Finance Committee Chairman Rep. Ryan Smith (R-Gallipolis) provided an outline of how the House substitute budget bill allocates \$170.6 million.

Local business leaders and tax practitioners around the state apparently are talking mostly to their state associations and the tax commissioner about their concerns with the imposition of municipal income tax on business net profits, because some members of the Senate Finance Committee said they have heard nothing on the issue even though Tax Commissioner Joe Testa pegged the savings to businesses in compliance costs at \$800 million. Testa, testifying before the full finance committee on the tax proposals contained in the governor's proposed FY18-19 budget, HB49 (R. Smith), provided an expansive explanation of the proposal whereby his department would serve as the sole administrator of the municipal net profits tax on business entities via an expanded Ohio Business Gateway (OBG) — a proposal that has drawn strong opposition from local government. He repeatedly noted they are bringing the proposal to the Legislature on behalf of businesses in the state.

Senate President Larry Obhof (R-Medina) provided a forecast of Senate budget deliberations, saying the upper chamber is facing major cuts to HB49 (R. Smith) and a focus on outcomes rather than sheer dollars when it comes to the opioid crisis, public education and other concerns. "I do expect that there will be a lot of challenging decisions that need to be made over the next few months," he said. "I think the Senate will significantly decrease the amount of money being spent in this budget."

### **Economic Development**

Leading economic indicators for Ohio's private development agency dropped below 2012 numbers last year after two straight years of growth, as capital investments fell by nearly a third in 2016. Total new projects and new jobs commitments negotiated by JobsOhio trailed the previous year's performance by double digits. Retained jobs were way up in 2016, however, suggesting the nonprofit agency is having an easier time getting companies to agree to remain in Ohio than to relocate here or to actually expand their operations.

Gov. John Kasich announced the approval of assistance for seven projects set to create 641 new jobs and retain 846 jobs statewide. During its monthly meeting, the Ohio Tax Credit Authority (TCA) reviewed economic development proposals brought to the board by JobsOhio and its regional partners. Collectively, the projects are expected to result in more than \$32 million in new payroll, and spur more than \$167 million in investments across Ohio.

### Employment/Unemployment

The national unemployment rate dropped from 4.7 percent in February to 4.5 percent in March as total nonfarm payroll employment edged up by 98,000 jobs, the U.S. Bureau of Labor Statistics (BLS) said. The number of unemployed persons decreased by 326,000 over the month to 7.2 million, BLS said. The unemployment rates for adult women, whites and Hispanics declined in March, while other groups showed little or no change.

Ohio's unemployment rate remained at 5.1 percent in March, the Ohio Department of Job and Family Services (ODJFS) said, as the state dropped 4,100 jobs and the number of unemployed was unchanged. According to ODJFS, Ohio's nonagricultural wage and salary employment went from a revised 5,522,800 in February to 5,518,700 in March. The number of unemployed workers was 294,000 in March, unchanged from February. The number of unemployed has increased by 9,000 over the past 12 months, when there were 285,000 unemployed. The March 2016 unemployment rate was 5.0 percent.

#### **Environment**

Environmental organizations are seeking to force the federal government to address Ohio's list of "impaired" waters under the Clean Water Act. The National Wildlife Federation (NWF), Ohio Environmental Council (OEC) and other groups have filed a lawsuit against the U.S. Environmental Protection Agency (USEPA) in the U.S. District Court of the District of Columbia, arguing the federal agency is taking too long to approve or deny the Ohio Environmental Protection Agency's (Ohio EPA) 303(d) list in the "Ohio 2016 Integrated Water Quality Monitoring and Assessment Report." In a news release, OEC said the agency needed to make a decision on the list in 30 days, noting the list was submitted in October 2016.

#### Federal

The still-young administration of Donald Trump was one of many federal issues discussed at a Columbus Metropolitan Club (CMC) panel featuring U.S. Reps. Joyce Beatty (D-Columbus) and Pat Tiberi (R-Columbus). The panel titled "The First 100 Days" and moderated by WOSU's Mike Thompson, began with a discussion on the Trump administration and moved onto a wider range of topics, including immigration, redistricting and education, among others.

With congressional negotiators reaching a deal to keep the government funded through September, U.S. Sens. Sherrod Brown (D-OH) and Rob Portman (R-OH) noted the package included federal resources for states hit hard by the opioid and heroin crisis and funding for health care for Ohio miners, both issues the two have been fighting for recently. Portman noted that the bipartisan agreement fully funds the Comprehensive Addiction and Recovery Act (CARA), which he sponsored, and the CURES Act, and increases opioid funding.

U.S. Sen. Sherrod Brown (D-OH) outlined his recommendations for a renegotiation of the North American Free Trade Agreement (NAFTA), saying above all else, workers must be at the negotiating table so that they don't get left behind.

### General Assembly/Statehouse

Senate Minority Leader Joe Schiavoni (D-Boardman) said he's resigning leadership to focus on his candidacy for Ohio governor in 2018. The Senate Democratic Caucus elected Sen. Kenny Yuko (D-Richmond Heights) to replace Schiavoni. Later in the week, the Senate changed committee assignments to reflect the change.

Rep. Heather Bishoff (D-Blacklick) resigned, ending her term in the Ohio House immediately to focus on her family and growing the Bishoff Financial Group.

The House unanimously passed legislation that would eliminate the requirement that a special primary election be held for congressional races if a candidate drops out or in other certain cases. Under HB18 (Pelanda-Retherford), the special election would not need to be held if only one person files to fill the vacancy in the election, or if no candidates file for the seat.

#### Governor

The governor signed HB9 (Koehler), which specifies that the alternative protocol for proceeding into an intersection with malfunctioning traffic lights due to a failure of a vehicle detector applies only to bicycles, on Sunday, April 30. As an emergency measure, it became effective immediately.

The governor made the following appointments during the week: Charles O. Moore of Genoa Township (Delaware County) to the Ohio Police and Fire Pension Fund for a term beginning April 28, 2017, and ending Sept. 27, 2020.

### People

State Fire Marshal Larry Flowers retired Friday, May 5 after having served as Ohio's 37th fire marshal, having been appointed in April 2011. A former state representative, Flowers will be succeeded on an interim basis by Deputy Chief Fire Marshal Jeff Hussey.

The County Engineers Association of Ohio (CEAO) announced that Franklin County Engineer Dean C. Ringle will become the association's new executive director, effective July 1, 2017.

### **Transportation**

House Speaker Cliff Rosenberger (R-Clarksville) announced the appointment of Rep. Jonathan Dever (R-Cincinnati) to the Ohio Rail Development Commission (ORDC).

#### **Utilities**

The Ohio Consumers' Counsel (OCC) says a new bail-out of nuclear power plants following the failure of FirstEnergy's power purchase agreement (PPA) would only add to the billions of dollars in state-ordered subsidies customers have paid to regulated utilities in an otherwise deregulated energy market. SB128 (Eklund) would require participating electric utilities to buy nuclear energy "credits" to prop up FirstEnergy's Davis-Besse Nuclear Power Station and Perry Nuclear Generating Station in northern Ohio. Proceeds would go to a "zero-emissions nuclear resources fund" administered by the Ohio Treasurer of State for distribution to FirstEnergy and any other nuclear power plant that might emerge. Utilities' costs would then be charged to all participating ratepayers through a non-bypassable bill rider.

Former energy partner Daniel Conway joined his first voting session as the newest member of the Public Utilities Commission of Ohio (PUCO), which approved Dayton Power & Light's (DP&L) latest auction results and denied a second rehearing of its shutdown order against Ohio Rural Natural Gas.
