Basic Project Overview



- Intel announced a \$20 billion+ chip manufacturing project.
- New Albany / Licking County
- Plans to build two state-of-the-art factories by 2025.
- Opportunities for New Albany, Central Ohio and the State of Ohio:
 - thousands of new manufacturing and construction jobs
 - new infrastructure in and around New Albany to support the project
 - a stronger emphasis on STEM education opportunities throughout the state of Ohio.
- Megaproject = largest single private sector company investment in Ohio's history
 - 20,000 jobs in the state
 - 3,000 Intel direct jobs in Phase 1




A REGION OF 3 MILLION PEOPLE BY 2050



Central Ohio Population Projection

- MORPC and LCATS Metropolitan Transportation Plans (MTP or LRTP)
- CORPO Transportation Plan
- *Identifies regional transportation strategies and projects*
- *Long-range (20+ years)*
- *Fiscally constrained*
- *Formal document submitted to ODOT and USDOT every 4 years*




COMPREHENSIVE REGIONAL MTP PROCESS



POPULATION & EMPLOYMENT FORECASTING



MORPC

- Developed for 7-county region
- Presented at traffic analysis zone (TAZ) level
- Process and Inputs:
 - Establish base year (2020) estimates of population and employment
 - Develop forecast year (2050) county control totals to project total growth
 - Update future land use from local land use plans & points of interest
 - Distribute growth using land use, commuting patterns, and factors that attract/deter development
 - Revisions based on local review



Key Inputs to Travel Demand Model to Develop Traffic Forecasts

FORECASTING & TRAVEL DEMAND MODELING



MORPC

- Completed regionally on 4-year MTP cycle
- *Reviewed and updated as needed for:*
 - Small Area Studies
 - Corridor Studies
 - Other Special Studies

REGIONAL TRANSPORTATION PROGRAMMING

Transportation Improvement Program

- Local government & ODOT
- **consensus on regional priorities**
- **Comprehensive listing** of transportation projects
 - All federally funded projects
 - All other regionally significant projects
 - Highway, transit, bikeway, and pedestrian modes
- Summary of project **scopes, schedules and costs**
- Communicates this information to diverse parties
- Needs approval from MORPC, Governor, and U.S. DOT


- Burgess & Niple has been selected to perform thoroughfare plans for both Unincorporated Licking County & City of Newark


SR 161 WIDENING

- U.S. 62 to I-270
- SR 161 west ramp to I-270 north
- Construction to begin Summer 2023
- Additional lanes open by Nov. 2024



SR 161 AND MINK ST. INTERCHANGE IMPROVEMENTS

- Widen to two through lanes plus turn lanes
- Turn lanes on exit ramps
- Construction to be a part of New Albany's Mink St. project
- Complete May 2024






NEW ALBANY ROAD IMPROVEMENTS (INTEL-RELATED)

Five-lane roadway section: four total drive lanes with a center turn lane or median



MORPC 2020-2050 MTP

-  Intersection Modification
-  Interchange Modification
-  New roadway
-  Convert to Freeway
-  Major widening (add through travel lanes to roadway or freeway)
-  Minor widening (add center turn lane to non-freeway)
-  High Capacity Transit (including but not limited to Bus Rapid Transit, rail, streetcar, etc.)
-  Stand-alone Bicycle or Pedestrian



INTEL-NEW ALBANY TIS

Important Assumptions and Criteria

- StreetLight, Trip data from Intel, ODOT's Travel Demand model; Baseline 2019; Years 2025 and 2035; 0.5% Growth Rate
- The Full Build Intel site estimate of 14,000 employees. Phase 1 estimated 3,500 employees and approximately 6,000 trade workers on site for construction of the New Albany Technology Manufacturing District (TMD).
- Phase 1 plus construction traffic would be approximately 78% of the Full Build trips generated by the site
- Other regional studies outside the TMD may be considered by ODOT and other municipalities but are not a part of this study

Figure 2 - Study Roads, Regional Intersections, and Intel Site (Yellow)






Findings and Recommendations

- 10 New Roundabouts and 15 New Signals inside TMD
- 81% traffic from south on Beech, Mink, SR 62; 7% from East
- Full build Volumes:
 - USR 62 (Central College–Green Chapel) 28-35K ADT (Future Improvement Recommended)
 - Mink (Miller-Green Chapel) 13-18K ADT (5-lane)
 - Clover Valley Ext (Jug-Mink) 21K ADT (3-lane)
 - Green Chapel (62-Mink) 22-28K ADT (5-Lane)
- No improvements Proposed outside TMD to East or North




Intel-New Albany TIS Traffic Distribution

General Information


- No State Routes Touch the TMD
- 14.1 Miles County and Twp Roads between TMD and SRs 310,37 and USR 62
 - 4.75 mi Major Collector,
 - 4.54 mi Minor Collector,
 - 4.73 mi Local
- Poor pavement conditions, 18-22 ft width; some poor geometry and Drainage

Licking County TID Improvement Project

Proposals

- Local Road Improvement Scope of work
 - Repair, Resurface, Minor Widening, Geometric and Drainage Improvements for 14.1 Mi
 - Total Cost: \$6.4M (Incl \$513K PE+10% Const Contingency)
- TID Grant application March 31
 - PE, 500K
 - Begin 7-14-2022, Complete 12-1-2023
- Community Projects Funding Congressional Earmark Request April 1
 - Construction, 4.7M (Major and Minor Collectors*)
 - Begin 3-1-2024, Complete 9-1-2024
- Other Targeted funds incl ODOT J&C, OPWC, SIB
- Recently Received Local Road TIS Proposal from MS Consultants

- LCATS is applying for a multimodal mobility RAISE planning grant with assistance from MORPC, ODOT Office of Transit and related stakeholders - *Grant selections will be made by August 12, 2022*
 - Objective if funded this study will
 - Identify a multimodal mobility network that supports economic opportunity and sustainability goals for Licking County and the surrounding areas.
 - Develop a sustainable and equitable mobility ecosystem that meets the growing needs for employment access and opportunity for commuters, while also supporting mobility independence for underserved populations
 - *Study Planning Process*
 - Defining the need with data
 - Clarifying the vision with engagement
 - Guiding the implementation of warranted innovation
