MORPC Sustainability Advisory Committee Board/Working Group Report April 20, 2022



Central Ohio Greenways Board (Chair: Mike Andrako, P.E.) Next meeting May 18, 2022

The Central Ohio Greenways (COG) Board met on March 9, 2022. The Board discussed formation of a Nomination Committee, which would assist with filling open Board and working group seats by reaching out to potential members who can bring additional insights and expertise. The group also chose to temporarily merge the Trail Development & Partnership working groups and the Marketing/

Communications & Operations/Access working groups, to facilitate intersections in their work over the coming months.

<u>Trail Development and Partnership Working Groups</u>: Members have begun meeting with Central Ohio communities to learn more about current and future trail projects and discuss how COG can support those efforts, through regional coordination, grant funding applications, and more.

<u>Marketing & Communications and Operations & Access Working Groups</u>: Mark your calendar for Saturday, April 23rd from Noon to 5 PM, and join COG partners for Celebrate Trails Day. Events will take place in communities across Central Ohio, including Dublin, London, and Knox County. Additionally, MORPC staff, COG partners, trail user groups, and community organizations will be participating in a Celebrate Trails event at Genoa Park, as part of the Earth Day Columbus celebration. Thank you to Eric Oberg and the Rails to Trails Conservancy for lending their leadership and support to this event.

April 23rd also marks the relaunch of the Outdoor Trails Passport in partnership with Experience Columbus. This online application rewards trail users with an opportunity to win prizes by checking in at over two dozen locations across the COG network. Watch for media campaigns advertising the passport and the unique locations along the trails.

Working group members continue to advise MORPC's Trail Town Framework planning effort, which will provide recommendations to rural towns and communities on how to utilize trail connectivity for economic development, tourism, and quality of life: all steps communities may take toward launching a trail town program. The project remains on schedule to wrap up in July 2022.

Finally, a MORPC/COG proposal to complete a regional trail wayfinding strategy was selected to be included in the ODOT SFY23 Statewide Planning & Research (SPR) Part A Work Program. Pending FHWA approval, this project will assist communities to plan for and implement a cohesive wayfinding strategy that unifies the COG trail network and celebrates the uniqueness of Central Ohio's communities. The project will result in a guide that recommends a cohesive regional approach to wayfinding.



Energy & Air Quality Working Group (Chair: Matt Stephens-Rich) Next meeting: May 24, 2022

The Energy and Air Quality Working Group had its second meeting of the year on March 22 with a specific focus on an education and engagement strategy surrounding SB 52 and the new powers it gives county commissioners and township trustees to restrict utility-scale solar and wind. After being briefed by Steve Tugend of Kegler Brown Hill + Ritter, the group heard two perspectives from working group members Dale Arnold of the Ohio Farm Bureau Federation and Zach McGuire of the Columbus Partnership. From the discussion the working group recommended drafting the "Energy Generation Policy Brief": a policy guide targeted for local government officials and community leaders to address land use, clean energy generation, climate mitigation, and economic opportunities that solar projects can provide in the MORPC region. Once completed and reviewed by the working group, the chair will take the policy guide before the Sustainability Advisory Committee for further review.

In energy-related programming, the cities of Delaware and Upper Arlington recently earned bronze and gold SolSmart designations, respectively, making the process of doing solar easier in both communities. Upper Arlington became the first community to earn gold in the state of Ohio. Additionally, MORPC is continuing to speak with any local government and or school district leaders who are interested in bringing solar, EVs, and electric buses to their communities through the Regional Schools Energy Strategy or ReSES. March 1 marked the start of ozone monitoring season. Staff continues to move forward with the neighborhood level air monitoring program and worked with Franklin County Public Health to apply for a federal air monitoring grant with a focus on environmental justice and health disparities. COSI is producing signage and will be hosting an air monitor at their facility. The team is also planning for Air Quality Awareness Week May 2-6.



Sustainable2050 Next meeting: Friday, June 17, 2022

The March 18 meeting focused on waste reduction, composting, and recycling with a presentation from Kyle O'Keefe from SWACO. The group was also invited to share examples of local ordinances that promote sustainable practices to include in a Local Government Legislative Toolkit that is in process. Metro Parks volunteered

to coordinate with MORPC to plan the June member meeting featuring the topic of green space protection with updates on Rapid 5.

Sustaining Scioto Board (Chair: Glenn Marzluf)

Next Meeting: April 27, 2022

The Board met on February 23 with a featured presentation by Bartlett Durand, Jr. Esq. of Sand County Foundation on the topic *Municipal-Agriculture Watershed Partnerships in Iowa* — A Successful Approach to Water Quality Improvement. Sand County Foundation is a national nonprofit conservation working at the intersection of agriculture and environmental improvement. Dr. Matthew Hamilton, Asst. Professor from the College of Food, Agricultural, and Environmental Services also gave a presentation on behalf of

his capstone class on Farmer and Non-Farmer Stakeholder Engagement in the Scioto Watershed:

Findings from OSU Capstone Projects. Recommendations including providing information on nutrient management, on-farm research, cover crops, and increased education within communities will guide program development and outreach of the Agricultural & Rural Communities Outreach Team.

<u>Agricultural and Rural Communities Outreach Team:</u> The Team met virtually on March 17, and listened to a presentation by Mark Wilson, American Farmland Trust, "*Farming for Cleaner Water in the Upper Scioto Watershed: A Story Map.*" Chair Brian Brandt led the group to discuss coordination involved in organizing a field day/farm demonstration tour focused on learning about best management practices for water quality and flood management in the Scioto Watershed. The Team also discussed coordination for a webinar focused on highlighting the Sustaining Scioto Board and its goals. Next meeting is scheduled for May 19th.










Intel Site Driving Times


