Data Team – Adam Porr

- The Team is working toward the completion of the 2024 MTP, focusing on population and job forecasting.
- Population estimates should be completed by the end of Summer 2022.
- Staff recently completed a Robert Woods Foundation Grant application to assist the City of Columbus with Resilience Hubs.

Working Group Reports

<u>Local Government Resources</u> – *Member McCollough*

The Group continues to work toward creating a toolkit for member municipalities to use for their data governance. Two current challenges are being addressed: (1) How to meet varied needs across Central Ohio, and (2) How to expeditiously share quality resources. The intent is to not

The other initiative of the Working Group is to pair up data professional with non-profits to help with their data needs. The Human Services Chamber will be the clearinghouse for the project.

Regional Municipal Fiber Strategy - Members Oliver & Orth

There are currently 19 municipalities interested in being part of this strategy. Since 2020, more federal funding has become available, which may be used to light the backbone of the system and connect to municipalities. Working Group Chairs Oliver and Orth hope to expedite the project to take advantage of the new funding available.
