**Welcome & Group Administration**

William Murdock and Kerstin Carr introduced themselves and thanked members for attending. Kerstin introduced MORPC staff contacts. Chair Atha and Vice-Chair Andrako introduced themselves.

**Sustaining Scioto Background**

Purpose

Sustaining Scioto's aim is to identify risks to the region's water resources due to climate change, and to bring stakeholders together for collaboration.

Background

In 2011, MORPC brought partners together to initiate the [Sustaining Scioto Study](#) to identify risks to the region's water resources due to climate change.

Study Findings & Process

The collaborating partners created a process:

- Understand Projected Impacts and Challenges
- Identify Risks
  - Threats & Vulnerability Assessment identified key sectors impacted by climate change:

- Lower water quality
- Damage to infrastructure
- Loss of power due to extreme weather events
- Determine and Evaluate Adaptation Options
  - Short Term 2015 – 2025
  - Mid Term 2026 – 2045
  - Long Term 2046 – 2090
- Implement and Monitor
- Re-evaluate and adjust as new information becomes available

### **How We Got Here to the Sustaining Scioto Implementation Plan**

Public meetings of Sustaining Scioto Subcommittee began in August 2017, addressing recommendations in the Sustaining Scioto Study. The group identified the agricultural community and public water systems as populations to engage. The American Farmland Trust has been very helpful in engaging the Agricultural community.

### **2020 Priorities, Board Role, and Funding**

Staff recommendations are informed from findings in the [Sustaining Scioto Adaptive Management Plan](#), which identified and quantified the impacts of future climate change.

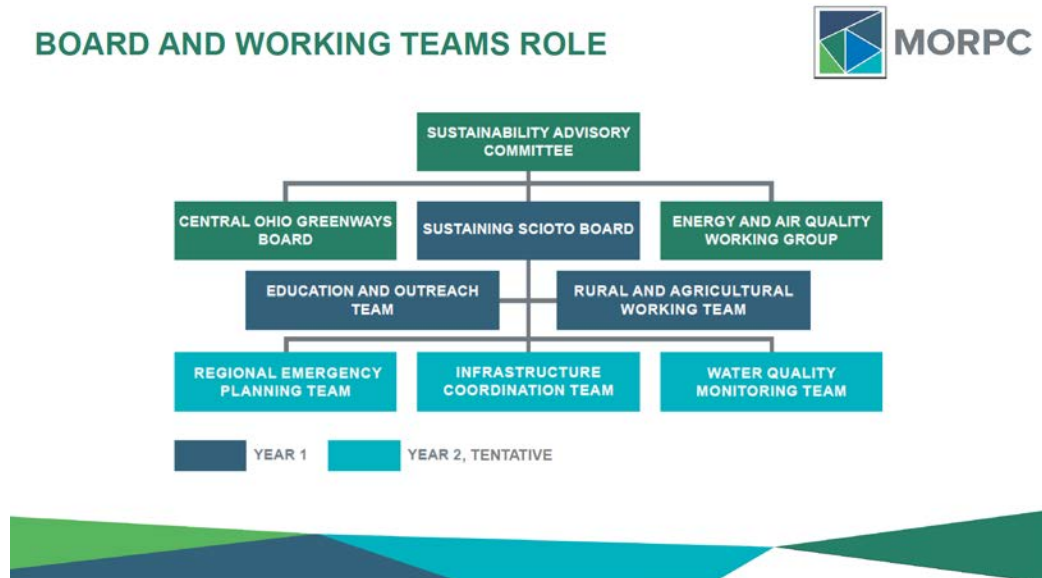

- Informed Decision Making
  - Strategy 1 Establish Leadership structure & sustainable program funding (formation of the ss board)
  - Strategy 2 Create and update climate data tools and projections to support planning and implementation initiatives (is to develop a scope of work, finding consultants, and identify funding opportunities)
  - Strategy 3 Develop and implement a comprehensive Water Quality Monitoring Program ( is to develop a scope of work for types of water quality monitoring, finding consultants, and identify funding opportunities)
- Prepared & Connected Communities
  - Working Teams will be created and be chaired by members of the Sustaining Scioto Board.
  - Strategy 1 Establish Public Outreach Team
  - Strategy 2 Develop Outreach Framework
- Protected Resources
  - Strategy 1 Develop a cooperative program with Agricultural Community to reduce runoff pollutant loads. The Board will create a Rural and Agricultural Working Team to inform the board how to best complement existing efforts.)

Review the Board's Role and Plans for Working Teams  
Sustaining Scioto Organizational Chart:



The Sustaining Scioto Board will be a standing board of the Sustainability Advisory Committee; the Chair and Vice-Chair of the Board will also be Sustainability Advisory Committee members. In the first year, the Sustaining Scioto Board will be supported by two working teams, the Education & Outreach Team and the Rural & Agricultural Working Team. In the second year the Board may want to form other teams, such as the Regional Energy Planning Team, the Infrastructure Coordination Team, and the Water Quality Monitoring Team.

MORPC staff will present Bylaws at the next Board meeting for member's review and approval.

Funding

Current funders are DelCo Water, the City of Marysville, and the City of Columbus Department of Public Utilities. MORPC staff plan to apply to the Ohio Water Development Authority Research & Development Grant Program. The funding available is \$200,000 per year with matching funds and a three-year renewal. The deadline for application is October 2, 2020.

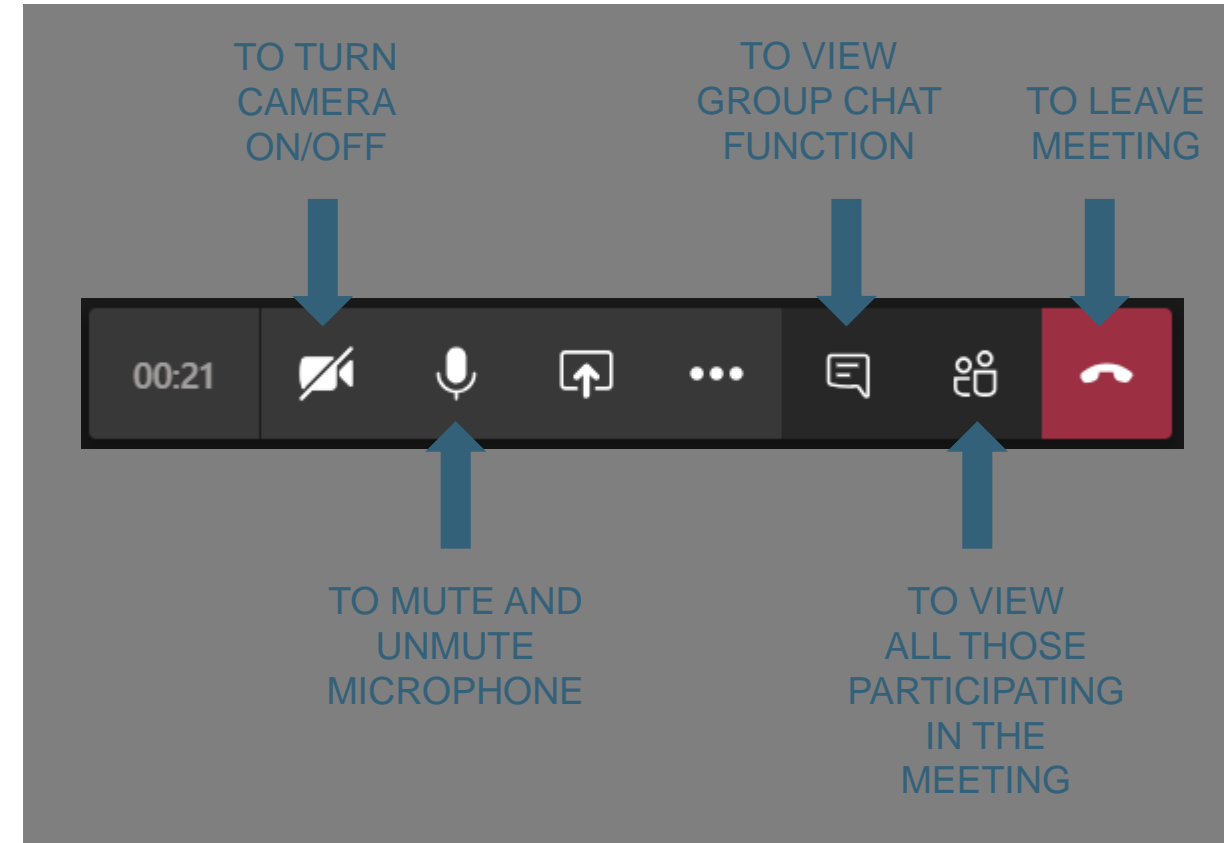

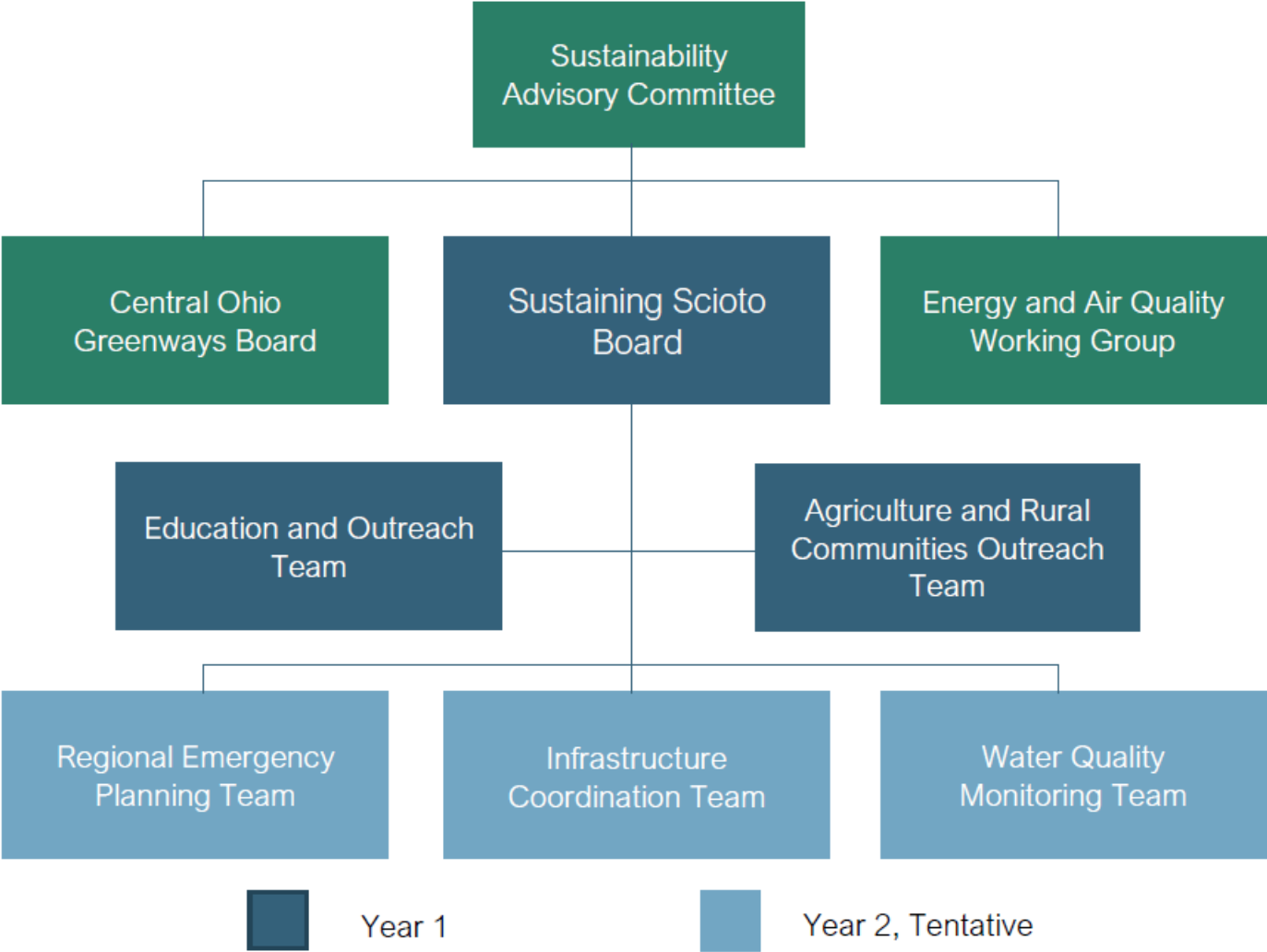

## **Board Role and Expectations:**

- Serve as the voice of and driver behind regional climate adaptation to secure clean and abundant water for everyone.
- Attend regularly scheduled Board meetings, or send a proxy in the event that you can't attend.
- Provide input and support key objectives of MORPC's Public Policy Agenda and the SAC Agenda.
- Establish working teams as needed to address project implementation, funding, education and communication, and marketing.
- Advise and utilize the expertise of each working team under the Board.



# SUSTAINING SCIOTO BY-LAWS

## **Term**

The Chair and Vice Chair will have a 2-year term on the Board. After the 2-year term expires, the SAC Chair and MORPC's Executive Director shall appoint a Chair and Vice Chair with the advisement of MORPC staff with the option to renew the term of the standing Chair and Vice Chair not to exceed two terms.

To stagger the expiration of terms, one-half of the initial members shall serve for one-year terms and one-half of the members shall serve for two-year terms. Thereafter, as terms expire, all members shall serve two year terms with the option to renew upon being nominated and approved by the Board Chair and MORPC's Executive Director.

## **Working Teams**

Board members are encouraged to either chair or be a member of one of the working teams as described below.

Initially, working teams will be established to focus on partnership, education and outreach, and the rural and agricultural communities. Other working teams may be established after the first year to focus on regional emergency planning, infrastructure coordination, and water quality monitoring. Each working team will be chaired by a Board member and will include both fellow board members as well as other interested stakeholders. The working teams will also coordinate with each other.



# SUSTAINING SCIOTO BY-LAWS

## **Conflicts of Interest**

Whenever a Chair or Member has a financial or personal interest in any matter coming before the Sustaining Scioto Board, the affected person shall a) fully disclose the nature of the interest and b) withdraw from voting on the matter.

## **Quorum**

A quorum shall be defined as those members present (virtually or physically) and eligible to vote at any meeting. An affirmative vote of a majority of the quorum is necessary for any action taken.

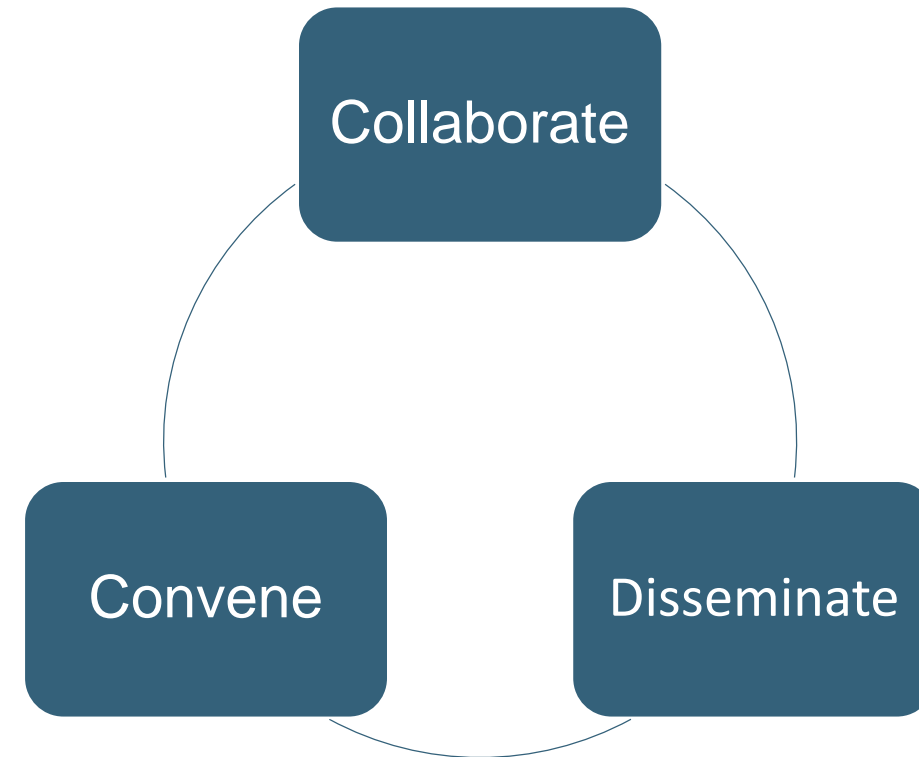

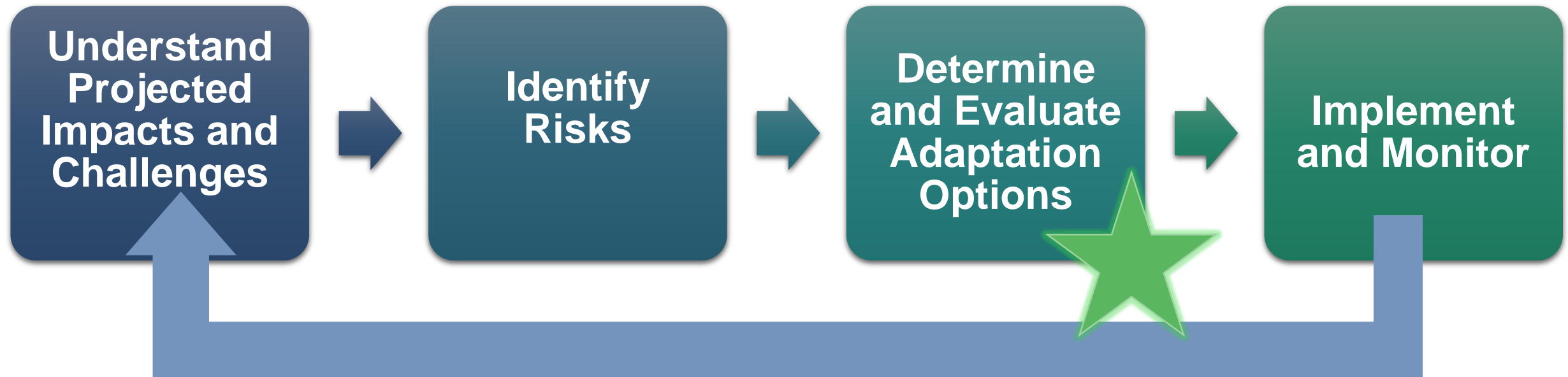

- Re-evaluate climatic conditions

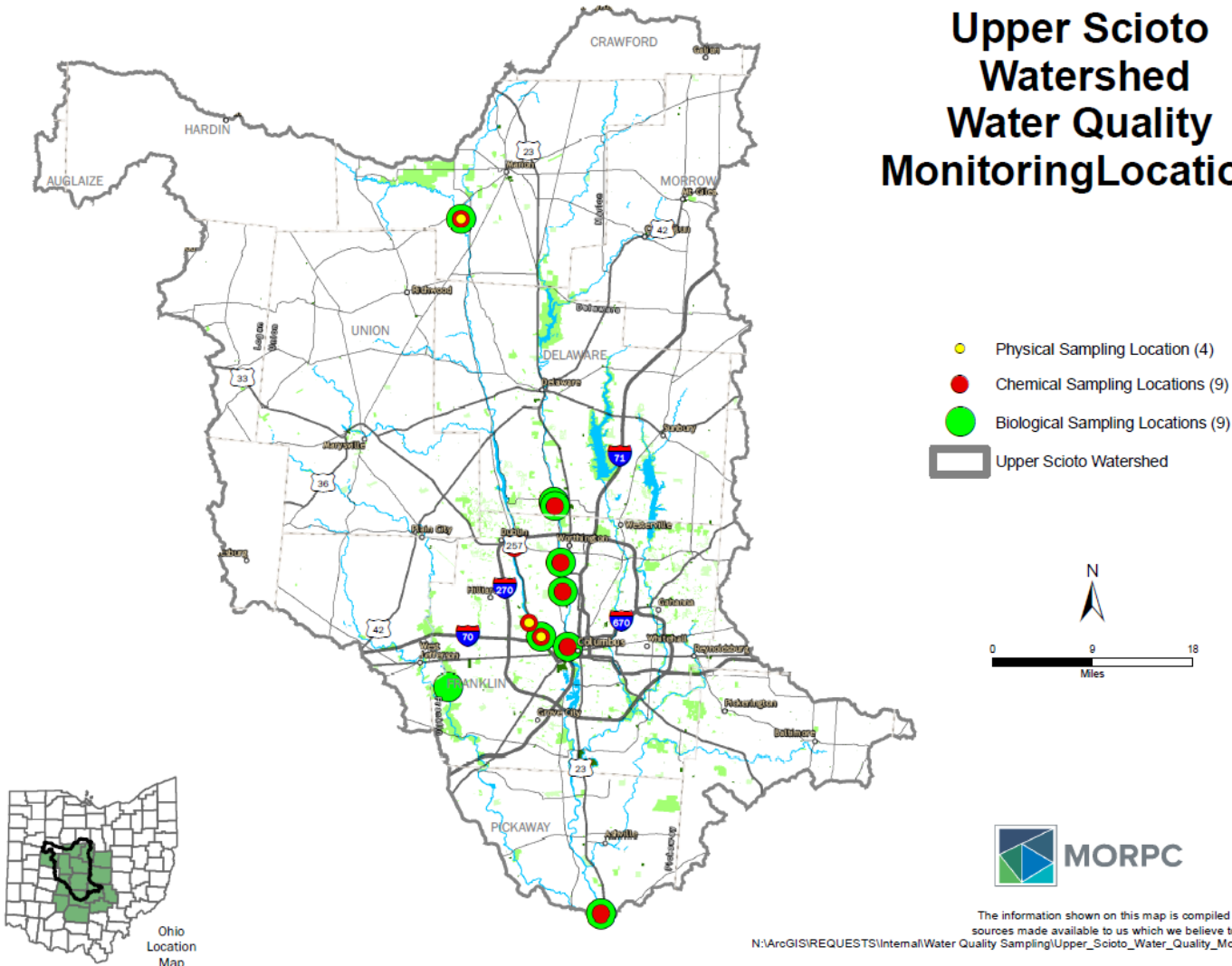
