## What's Happening

### *Voters Nominate DeWine and Whaley to Face Off in November*

Ohio voters came to the polls on Tuesday, May 3rd to nominate Republican Governor Mike DeWine and Dayton Mayor Nan Whaley in contested partisan primary elections for Governor. DeWine won 48% of the vote, besting challengers Jim Renacci's 28%, Joe Blystone's 21.8%, and Ron Hood's 2.1% of votes cast.

Whaley won her contested primary with 65% of the vote to defeat Democratic challenger and former Cincinnati Mayor John Cranley, who captured 35% of the vote.

In the race to replace retiring U.S. Senator Rob Portman next year, Republican JD Vance won a crowded and expensive primary by capturing 32.2% of the vote over his challengers. Vance will be facing Democrat U.S. Rep. Tim Ryan, who won his primary with 69.7% of the vote.

In other statewide races, winners included Republican Frank LaRose and Democrat Chelsea Clark for Secretary of State, Republican Dave Yost and Democrat Jeffrey Crossman for Attorney General, Republican Keith Faber and Democrat Taylor Sappington for State Auditor, and Republican Robert Sprague and Democrat Scott Schertzer for State Treasurer.

Also in November, Republican Sharon Kennedy will face Democrat Jennifer Brunner for Chief Justice of the Ohio Supreme Court. In addition, Republican Patrick DeWine will face Democrat Marilyn Zayas for Associate Justice, while Republican Patrick Fischer will face Democrat Terri Jamison for Associate Justice.

# What's Happening

## *Ohio General Assembly Redistricting Update*

Due to a back and forth between the Ohio Redistricting Commission and the Ohio Supreme Court, with the high court invalidating four sets of maps in 4-3 rulings, Ohio voters did not vote on members of the Ohio General Assembly during the May 3rd Primary election.

In April, a three-judge federal panel pushed its date of last resort back to Saturday, May 28. If the Ohio Redistricting Commission does not come up with a new plan by then, the judges said, they will order the use of the third plan adopted by the Ohio Redistricting Commission for the upcoming election.

In a per curiam opinion, U.S. District Chief Judge Algenon Marbley, U.S. Circuit Judge Amul Thapar and U.S. District Judge Benjamin Beaton agreed a case brought by Republican activists has standing and that they must act in the federal lawsuit if the state does not resolve its redistricting issue. Marbley, however, dissented on the remedy that the court should order which appears to negate the need for any further action by the commission and clears the way for a second primary on Aug. 2.

Ohio Secretary of State Frank LaRose rejected a statement in the most recent Ohio Supreme Court opinion, signed by Chief Justice Maureen O'Connor and Justices Jennifer Brunner and Melody Stewart, which suggested that the state could hold a primary for General Assembly candidates in late August or September. LaRose commented, "To be clear, any primary held after Aug. 2 would directly conflict with the statutorily required deadlines of the General Election."

Following the latest Ohio Supreme Court decision which invalidated a fourth set of General Assembly maps, the Ohio Redistricting Commission met on May 4th to reject a motion by Sen. Vernon Sykes (D-Akron) to rehire independent mapmakers Michael McDonald and Douglas Johnson to finish their work on a set of maps they created following the Supreme Court striking down the third redistricting plan.

Ohio Secretary of State Frank LaRose stated it would be nearly impossible to implement any other map, even with slight changes to the third map, without help from the Legislature to move statutory deadlines. LaRose laid out the upcoming deadlines, including validating candidate petitions, certifying the official form of the ballot, and mailing out the first ballots to overseas voters by Friday, June 17 assuming a Aug. 2 primary date. Senator Robert McColley (R-Napoleon) stated at the hearing he was not certain there would be enough votes in the Senate to alter any of the statutory deadlines that LaRose cited.

The Commission met again on May 5th and voted 4-3 to resubmit the February 24th approved legislative map, its third of the four previously approved versions, for use in the 2022 elections.

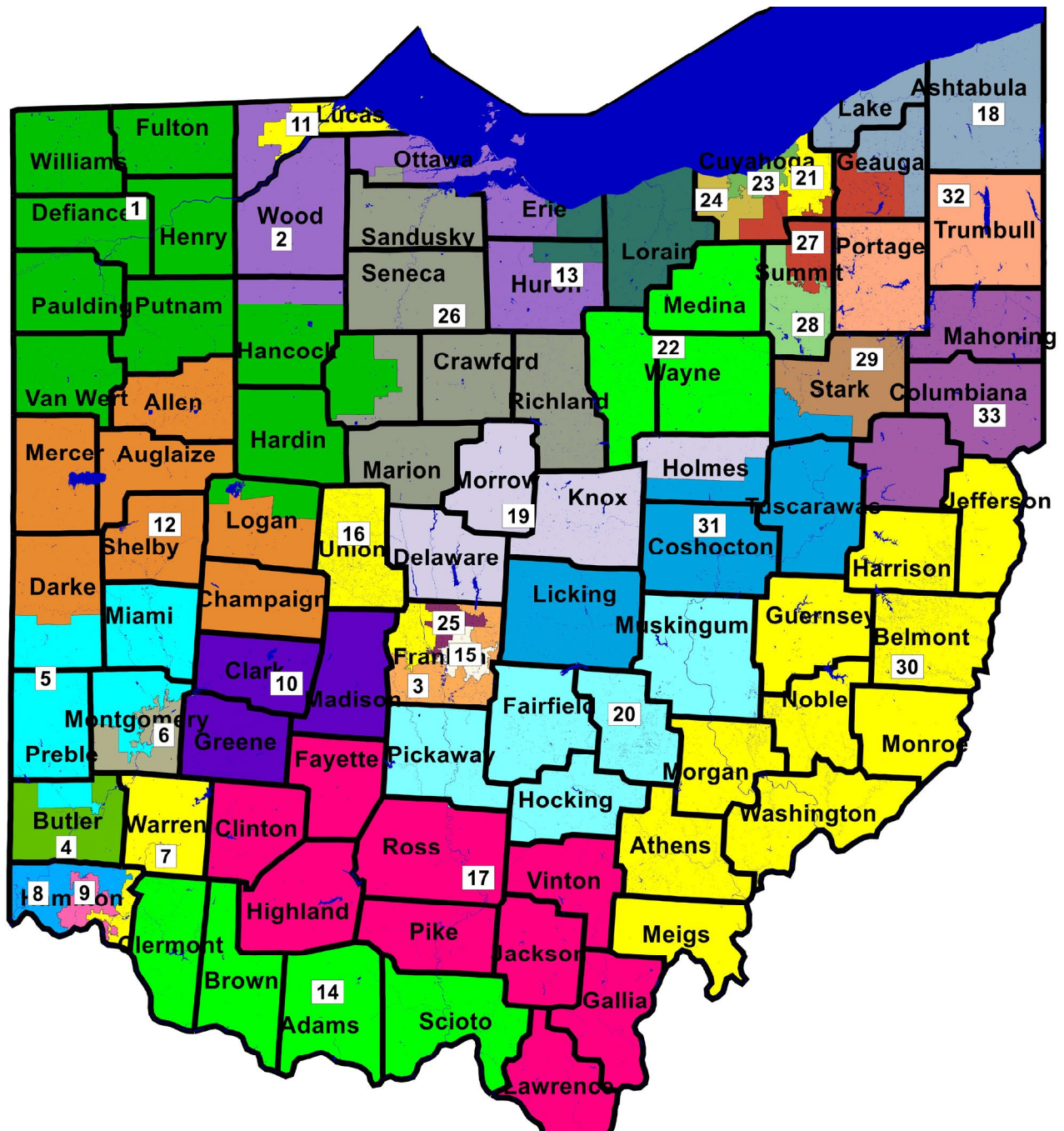

# Top News

## ***FY22-23 Budget***

Preliminary revenue data released by the Office of Budget and Management (OBM) for April show the state finished the month \$1 billion or 45.6 percent over estimates, bringing in a total of \$3.3 billion compared to estimated revenue of nearly \$2.3 billion. This excess revenue was driven by personal income tax (PIT) receipts of nearly \$894.7 million or 89.2 percent over estimates for April. OBM attributes the large variance to “stronger than anticipated payments from annual tax return filings.” All other major sources of General Revenue Fund dollars were also over estimates. So far, through 10 months of FY22, the state has collected a total of nearly \$22.9 billion or 12 percent over the estimated revenue of nearly \$20.5 billion. Compared to this time in FY21, the state has collected nearly \$2.1 billion more than was collected through April 2021.

## ***Census***

The U.S. Census Bureau and National Archives released records from the 1950 Census, as 2022 marks the end of the 72-year window in which decennial census records remain confidential. The records are available at <https://1950census.archives.gov/>. “Since 1790, census data have painted a vivid, vibrant portrait of America. While the decennial census is constitutionally used to determine congressional apportionment to states, the completed forms can give us a unique peek into our nation’s past, to the delight of historians, genealogists, and to all of us, the public,” said Robert Santos, director of the U.S. Census Bureau, in a video message about the release.

## ***Economic Development***

Gov. Mike DeWine’s administration announced the approval of assistance for five projects expected to create 733 new jobs and retain 1,344 jobs statewide. During its monthly meeting, the Ohio Tax Credit Authority (TCA) reviewed economic development proposals brought by JobsOhio and its regional partners. The projects are expected to collectively result in more than \$58 million in new payroll and spur more than \$563 million in investments across Ohio.

Gov. Mike DeWine, Lt. Gov. Jon Husted and Department of Development (DOD) Director Lydia Mihalik all spoke at events around the state, announcing distribution of \$60 million in the first round of Brownfield Remediation grant funds. The program has a total of \$350 million and launched in December 2021. DOD will provide funds for 78 projects in 35 counties as part of the first round, including \$54.8 million for 37 clean-up projects and \$5.5 million for 41 assessment projects. The program focuses on industrial, commercial and institutional brownfield sites that had been abandoned, idled or underutilized because of the known or potential release of hazardous substances or petroleum.

## ***Elections 2022***

Rep. Kristin Boggs (D-Columbus) is seeking a seat on Ohio’s 10th District Court of Appeals, forgoing her last term in the General Assembly. She would have faced term limits after the 135th General Assembly. Boggs was elected to the Ohio House in 2016, previously serving as an assistant Ohio attorney general, where she represented state agencies and universities in civil actions filed in the Court of Claims.

Gov. Mike DeWine Tuesday did not have to wait long to give a victory speech in the Republican primary for governor. Within 45 minutes of the polls’ closing at 7:30 p.m., multiple news outlets including the Associated Press called the race for him. DeWine, who had drawn heat from some conservatives over the way he handled the pandemic in Ohio, easily defeated former U.S. Rep. Jim Renacci, who came in second, farmer Joe Blystone and former state Rep. Ron Hood, who was a distant fourth.

Former Dayton Mayor Nan Whaley made history as the first woman to be nominated by a major party to be governor, overwhelmingly defeating former Cincinnati Mayor John Cranley to capture the nomination.

J.D. Vance won Ohio’s seven-way U.S. Senate Republican primary election. The Hillbilly Elegy author, bolstered by the endorsement of former President Donald Trump, won the contest with about 32 percent of the vote. Former Treasurer of

State Josh Mandel received 24 percent, and Sen. Matt Dolan (R-Chagrin Falls) got 23 percent. Investment banker Mike Gibbons got 12 percent, while former Ohio Republican Party Chair Jane Timken received 6 percent. Businessmen Mike Pukita and Neil Patel got 2 percent and 1 percent, respectively.

U.S. Rep. Tim Ryan (D-Niles) is the Democratic nominee in Ohio's 2022 U.S. Senate race. Ryan, widely seen as the favorite in the primary election, received about 71 percent of the vote. Attorney/community organizer Morgan Harper came in second with 17 percent, and tech executive Traci (TJ) Johnson finished with 12 percent. Ryan celebrated his victory at Firefighters Local 67 in Downtown Columbus, joined by his family, Sen. Hearcel Craig (D-Columbus), Ohio AFL-CIO President Tim Burga, Ohio Association of Public School Employees (OAPSE) Executive Director Joe Rugola and U.S. Rep. Joyce Beatty (D-Columbus), among others.

All of the sitting members of Ohio's congressional delegation who are running for re-election didn't see their campaigns come to an end. U.S. Reps. Brad Wenstrub (R-Cincinnati), Bill Johnson (R-Marietta), Warren Davidson (R-Troy), Shontel Brown (D-Warrensville Heights), Troy Balderson (R-Zanesville) and David Joyce (R-Twinsburg) all defeated their primary challengers. In perhaps the biggest upset, Port Clinton's J.R. Majewski defeated three others, including Sen. Theresa Gavarone (R-Bowling Green) and Craig Riedel (R-Defiance) to win the Republican nomination for the 9th Congressional District and will take on U.S. Rep. Marcy Kaptur (D-Toledo), who with nearly 40 years in office is the longest serving woman in the U.S. House of Representatives.

## Energy

President Joe Biden announced that the U.S. Environmental Protection Agency (USEPA) is issuing an emergency waiver to relax federal restrictions on the sale of 15 percent ethanol fuel, or E15, between June 1-Sept. 15 in an effort to lower sticker shock during vacation driving season. E15 is generally cheaper than regular gasoline and the federal government says it is safe to use in cars manufactured in 2001 or later.

The Ohio Chamber of Commerce joined JobsOhio and Battelle Memorial Institute to urge the Biden administration to name the Buckeye State one of four Clean Hydrogen Hubs to be funded by \$9.5 billion from the Infrastructure Investment and Jobs Act (IIJA). Former U.S. Rep. Steve Stivers, Ohio Chamber president, joined Battelle CEO Lewis Von Thar, Managing Director Matt Cybulski of JobsOhio's Energy and Chemicals division, CEO Kirt Conrad of Stark Area Regional Transit Authority (SARTA) and CEO Angelo Kafantaris of Hyperion Corp., a hydrogen car manufacturer that launched in Columbus 10 years ago and is relocating its headquarters to the capital city after moving to California. The group said Ohio not only has not the shale natural gas for "blue" hydrogen production but also the biomass for renewably driven hydrogen and the generation capacity for "green" H electrolysis. The latter produces no carbon dioxide waste, which otherwise must be sequestered underground, and benefits from low- to zero-carbon electricity as the major input.

## Federal

The U.S. Senate voted 53-47 to confirm Ketanji Brown Jackson to the U.S. Supreme Court, making her the first Black woman to serve on the nation's highest court. U.S. Sen. Sherrod Brown (D-OH) voted to confirm Jackson, while U.S. Sen. Rob Portman (R-OH) voted against her confirmation.

## General Assembly/Statehouse

The Senate unanimously sent the capital reappropriations bill to Gov. Mike DeWine for his signature. HB597 (Oelslager) reappropriates \$2 billion in capital projects for FY23-24. Sen. Matt Dolan (R-Chagrin Falls) said that because of when the General Assembly passed the last capital budget as well as issues from the pandemic, a number of projects were not finished. He said HB597 needs to be in place by July 1 so the projects are not disrupted which means it must be passed by April 1. The bill does not include any new money.

The Senate also passed HB175 (Hillyer), which Sen. Tim Schaffer (R-Lancaster) said will clarify which ephemeral water features are regulated in the state and will align the state with federal policy. The bill passed 25-8 along party lines.

While most bills on the calendar passed with broad support, a few drew substantial opposition, including HB519 (Roemer-Lanese), which lowers the maximum penalty for failure to file a municipal income tax return to \$25, and specifies that municipalities can send notices to taxpayers who haven't filed, except those who've requested an extension on state and federal returns. The bill then passed 59-29.

Rep. Juanita Brent (D-Cleveland) is the new president of the Ohio Legislative Black Caucus (OLBC). Rep. Thomas West (D-Canton) resigned from his OLBC leadership position to focus more attention on his work as assistant minority leader of the House Democratic Caucus, OLBC said. The rest of the OLBC leadership team is as follows:

- » Rep. Catherine Ingram (D-Cincinnati) is first vice president.
- » Rep. Dontavius Jarrells (D-Columbus) is second vice president.
- » Rep. Terrence Upchurch (D-Cleveland) is treasurer.
- » Rep. Sedrick Denson (D-Cincinnati) is secretary.
- » Sen. Hearcel Craig (D-Columbus) is sergeant at arms.
- » Sen. Vernon Sykes (D-Akron) is parliamentarian.

## Governor

Bill signed by the governor: HB597 CAPITAL REAPPROPRIATIONS (OELSLAGER S) To revise the law regarding priority for classroom facilities projects for which the prior conditional approval lapsed and to make capital appropriations for the biennium ending June 30, 2024.

## Health + Human Services

Legislation that generally prohibits the promotion of "divisive concepts" by public schools, public universities, state agencies and local governments would harm efforts to reduce racial disparities in health outcomes, minority health advocates said during a Statehouse press conference. Ohio Poverty Law Center Policy Advocate Tim Johnson, PrimaryOne Health CEO Charleta Tavares, Children's Defense Fund-Ohio Executive Director Tracy Najera and First Congregational Church Senior Minister Rev. Tim Ahrens all urged House Speaker Bob Cupp (R-Lima) to publicly announce that HB327 (Grendell-Fowler Arthur) will not receive any more hearings in the House State and Local Government Committee. "The Legislature must acknowledge that the bill cannot be fixed. It cannot be amended to make it better. HB327 must not move forward, period," Johnson said. The controversial bill has also been condemned by education groups and free speech advocates, among others.

A newly released report shines a light on the availability of affordable housing in Ohio and across the country. "The Gap Report," released jointly by the Coalition on Homelessness and Housing in Ohio (COHHIO) and the National Low Income Housing Coalition, shows a shortage of affordable and available rental homes for extremely low-income households. The report notes many of these households are severely cost burdened, meaning they spend more than half of their income on housing. According to the report, no state in the country has an adequate supply of rental housing affordable and available for extremely low-income households (ELI) — meaning those at or below the federal poverty guideline or at 30 percent of the median family income in the area, whichever is higher. In Ohio, the report shows a deficit of 254,545 rental units that are affordable and available to the state's 443,717 ELI households.

## Housing/Homelessness

Home sales fell nearly 5 percent in March compared to a year earlier, but the average sales price was up by double digits, according to Ohio Realtors. The association pointed out that the lower sales still exceeded comparable pre-pandemic figures. Sales of 11,832 homes marked a 4.8 percent decline from the 12,429 homes sold in March 2021, while the average price increased by 11.1 percent, from \$222,421 to \$247,123.

## ***Judicial***

Government bodies in Ohio have struggled with the prospect of executive session since last year's 12th District decision granting Chris Hicks of the Clermont County Republican Party Executive Committee \$80,000 in legal fees for county commissioners' apparent failure to conduct themselves lawfully, counsel told the Ohio Supreme Court in oral arguments. How to announce executive session under R.C. 121.22(G), how and whether public officials must show confidential proceedings didn't stray from their stated purpose, and whether the Open Meetings Act (OMA) could use an overhaul are now questions before the Court.

## ***Natural Resources***

The Ohio Department of Natural Resources (ODNR) detailed improvements to community trails made possible by funding from the Recreational Trails (RTP) and Clean Ohio Trails programs. ODNR administers the federal RTP grant program, which reimburses up to 80 percent of a project's cost. Chosen projects create and maintain trails, improve access for people with disabilities and provide education about trail safety and the environment.

The Ohio Department of Natural Resources (ODNR) Division of Geological Survey has released new groundwater maps that offer a highly detailed assessment of Ohio's aquifers and how vulnerable they are to pollution. They will serve as tools for land-use planning and development. Modern advances in data gathering and mapping technology allowed the division to develop maps with greater detail that evaluate the groundwater resources across county lines and throughout the state.

## ***Public Safety***

The Ohio State Highway Patrol (OSHP) and other members of the 6-State Trooper Project recently collaborated in a distracted driving project which ran from Monday, April 4 and ended Monday, April 11. The high-visibility enforcement included the Indiana State Police, Kentucky State Police, Michigan State Police, Pennsylvania State Police, West Virginia State Police and the Ohio State Highway Patrol. During the 6-State Trooper Project, the patrol cited 419 drivers with distracted driving.

## ***State Government***

Sen. Kirk Schuring (R-Canton) said he hoped a forthcoming meeting with Ohio Department of Development (DOD) Director Lydia Mihalik and Senate President Matt Huffman (R-Lima) will address concerns regarding a new scoring system for the Historic Preservation Tax Credit Program. Schuring had discussed the scoring with the Senate Ways and Means Committee earlier in regard to a potential amendment on HB95 (Manchester-Lightbody), though AM2968-1 was not formally offered and the committee voted the bill out. During comments to the committee — which he is not a member of — Schuring opened by detailing the history of his work to create the program and efforts of then-Lt. Gov. and DOD Director Bruce Johnson, Tax Commissioner Bill Wilkin and Senate Ways and Means Chair Ron Amstutz. The program has brought \$7 billion in investments to Ohio since then, he said, and “doesn’t need to be fixed.” The new scoring criterion, however, was applied to the latest round, which closed on March 31. Schuring said all types of housing should be treated equally, and affordable housing should be left to market forces in regard to the historic preservation tax credits.

## ***Taxation***

Schools and local governments will only be able to challenge property valuations for tax purposes if the difference between the sale price and county auditor's valuation exceeds 10 percent and \$500,000, under legislation headed to Gov. Mike DeWine's desk. The House and Senate both adopted the version of HB126 (Merrin) hammered out in a conference committee earlier in the day. The Senate approved it on a 24-8 vote. The conference report was approved on the House floor by a vote of 59-35.

Rep. Derek Merrin (R-Monclova), the bill sponsor and conference committee chair, has sought for multiple sessions to enact restrictions on the ability of political subdivisions to challenge valuations and to enter private-pay agreements where property owners agree to make payments in order to settle the disputes. Merrin said in the conference committee hearing that the final version would provide protection against "arbitrary and unwarranted complaints" and reduce property owners' uncertainty about their tax expenses. He called private-pay agreements, which are banned in the bill, "special, unseemly cash payments that distort values and treat taxpayers differently."

## ***Technology/Aerospace***

The Ohio Third Frontier Commission approved \$2.5 million in funding for tech startup companies in health care and defense industries, along with \$3 million for continued support of the Diversity and Inclusion Technology Internship Program helping grow Ohio's workforce and inclusive tech economy.

## ***Telecommunications/Broadband***

The Broadcast Educational Media Commission (BEMC) held its first meeting of 2022, hearing presentations on the state's ongoing efforts to expand broadband access as well as on a new collaboration among Ohio's public radio stations. Scott Gaughan told commissioners the pandemic shone a light on the "digital divide" across the state as well as showed how critical reliable broadband access has become, particularly for students. Gaughan is the director of Network Services at the Management Council - Ohio Educational Computer Network (MCOECN), which is the umbrella organization that provides connectivity to all of Ohio's K-12 schools.

## ***Transportation/Infrastructure***

Ohio Department of Transportation (ODOT) Director Jack Marchbanks appeared before the House Transportation and Public Safety Committee to update the members on the federal infrastructure law, to request a couple of law changes to make Ohio's use of those funds possible, and to discuss the impact should Sen. Steve Huffman's (R-Lima) SB277 — the gas tax rollback — pass. He said there were a number of caveats around the federal money including that, although it includes \$550 billion in new federal spending over the next five years, only the money for the current fiscal year has been appropriated. In addition, he said the funds come with "a lot of strings and carveouts." For Ohio that means while the state is due to receive more than \$11 billion over the five years, "a decent portion of that is already spoken for ...." He went on to mention the funding targeted for bridge repair and replacement including the Cincinnati Brent-Spence Bridge, as well as the new electric vehicle charging infrastructure and "unprecedented" amounts targeted to public transit and airports. The Ohio Department of Transportation (ODOT) announced the beginning of construction season in Ohio, saying it will invest nearly \$2 billion in 829 projects across the state. According to ODOT, crews will improve 661 bridges and 7,626 miles of pavement. There are also 222 projects aimed directly at improving safety on Ohio roads. ODOT noted that 95 cents of every \$1 that will be spent on construction will go toward preserving existing infrastructure.

Gov. Mike DeWine said that his administration will be sending \$47.5 million in extra funding for local bridge projects for the next five years thanks to federal funds enacted as a part of the federal bipartisan infrastructure law. DeWine and the Ohio Department of Transportation (ODOT) said the extra funds will bring Ohio's annual investment in county and municipal bridges to \$112.5 million per year. Funding from ODOT for bridges maintained by the state's 88 county engineers will increase from \$34 million to \$74 million annually, and municipal-owned bridge funding will increase from \$11 million

to \$18.5 million each year. The additional \$47.5 million is part of the \$104 million in bridge funding that Ohio will receive in each of the next five years as part of the federal infrastructure bill. It requires Ohio to spend \$15.6 million of the \$104 million each year into bridges owned by municipalities, townships and counties, but DeWine said his administration will be more than tripling the amount going to local communities.

Gov. Mike DeWine and Ohio Department of Transportation (ODOT) Director Jack Marchbanks announced the release of \$51 million for 44 new safety improvement projects to specifically address an increase in pedestrian-involved traffic crashes and fatal roadway departures on state and local roads. The funds come as fatal crashes involving pedestrians and roadway departures both hit their highest levels in 2021, compared to the previous decade.

## **Workforce**

Education and business leaders discussed how Ohio can prepare for the future workforce needs triggered by Intel's semiconductor production facilities in Central Ohio, as part of a wider forum on workforce and education hosted by Ohio Excels and the Governor's Office of Workforce Transformation. The hour-long panel was moderated by JobsOhio Senior Managing Director Kristi Clouse and included John Berry, president of Central Ohio Technical College (COTC); John Trott, executive director of the Area 7 Workforce Investment Board; Jack Thomas, president of Central State University (CSU); Jeff Spain, director of the Manufacturing Extension Partnership at Columbus State Community College (CSCC); Joyce Malainy, superintendent of the Career and Technology Education Centers of Licking County; and Steve Ringel, executive director of the Ohio State University (OSU) Institute for Materials Research.
