# What's Happening

### State Representatives to Choose a New Speaker of the House

Ohio House Speaker Bob Cupp (R-Lima) has served as Speaker of the Ohio House of Representatives since July 2020 following the removal of former Speaker Larry Householder who is still under federal indictment for potential violations of the RICO Act. However, Cupp will not return as Speaker in the 135th General Assembly due to term limits, as he was prohibited from seeking re-election to his Ohio House seat.

While it is unknown who the next Ohio House Speaker will be, at least four current Ohio House members have announced their candidacies to replace Cupp. Here is some background information on each of these four Speaker candidates.



**Rep. Brian Baldridge** (R-Winchester) is currently in his second term in the Ohio House and is running for the 90th House District which includes Adams and Scioto Counties. Baldridge chairs the Transportation and Public Safety Committee and is a member of the Finance Committee. Prior to joining the Ohio House, Baldridge served four terms as an Adams County Commissioner, two terms as a Wayne Township Trustee, and as a firefighter and paramedic with the Wayne Township Fire Department.



**Rep. Derek Merrin** (R-Monclova) is in his third term in the Ohio House and is running for the 42nd House District in Lucas County. Merrin is Chairman of the tax writing Ways and Means Committee and previously chaired the Health Committee. Prior to joining the Ohio House, Merrin served two years on the Waterville City Council and was elected Mayor of Waterville at 21 years old, becoming the youngest mayor in Ohio from 2008-2011.



**Rep. Phil Plummer** (R-Dayton) is in his second term in the Ohio House and is running for the 39th House District in Montgomery County. Plummer is Vice Chair of the Finance Committee. Prior to joining the Ohio House, Plummer served as Sheriff of Montgomery County, as well as other law enforcement positions such as SWAT Team Commander, Chief Deputy Sheriff, patrol deputy, and a corrections officer.



**Rep. Jason Stephens** (R-Kitts Hill) is in his first term in the Ohio House, following an appointment to fill the unexpired term of former Speaker and State Representative Ryan Smith. Stephens is running unopposed for the 93rd House District that encompasses Lawrence, Gallia, and Jackson Counties. Stephens is Chairman of the Energy and Natural Resources Committee and is also a member of the Finance Committee. Prior to joining the Ohio House, Stephens served as Lawrence County Auditor and Lawrence County Commissioner. He is also a licensed insurance agent and co-owner of an insurance company.

It is anticipated that the new Speaker will be known prior to the start of the next General Assembly, but the official vote will be held on the first day of House Session in January.





## What's Happening?

### DeWine Administration Announces EV Charging Infrastructure Grants

DriveOhio, a division of the Ohio Department of Transportation (ODOT), has begun accepting proposals from companies to apply for \$100 million in federal funding to install and operate electric vehicle (EV) charging stations in Ohio over the next five years.

Those companies applying for funding are required to align their proposals with Ohio's EV infrastructure deployment plan which mandates that charging stations support at least four direct current fast chargers with at least 150 kilowatts per port. As of now, Ohio only has 13 charging stations that meet this requirement and Governor Mike DeWine and Lt. Governor Jon Husted would like Ohio to add 30 more EV charging station locations by 2025.

Ohio's EV infrastructure deployment plan, which was approved by the Federal Highway Administration last month, will focus on interstate corridors before expanding on to U.S. and state routes. According to Governor DeWine's office, remaining funds following the completion of installing charging stations on federally-required corridors will go toward state tourist attractions and freight corridors.

Ohio's EV infrastructure deployment will focus on interstate corridors before moving on to U.S. and state routes. Once charging stations on federally-required corridors are complete, the remaining funds will be used for charging along additional corridors, at state tourist attractions and freight corridors, according to the governor's office.

### Bill Introduced in U.S. Senate to Prevent Frontover Child Deaths

Recently, U.S. Senator Richard Blumenthal (D-Connecticut) introduced the STOP Frontovers Act, which is intended to prevent child deaths due to frontover incidents. The bill has the support of auto and consumer safety organizations, including Kids and Car Safety, the Center for Auto Safety, Consumer Reports, and Advocates for Highway and Auto Safety.

This legislation would require all new vehicles to come equipped with cameras, sensors, or other technology to improve drivers' front visibility and perception of children, pets, and other objects that may be in front of their vehicle and avert crashes

Investigative reporters have recently uncovered that many cars have blind zones of up to 16 feet where drivers cannot see objects in front of them below the front of the vehicle, putting children and pets at risk of being run over and experiencing serious injury or death.

Blumenthal's bill would require the National Highway Traffic Safety Administration (NHTSA) to issue a new Federal Motor Vehicle Safety Standard (FMVSS) that requires vehicles be equipped with technology that enables drivers to detect and respond accordingly to objects in front of the vehicle to reduce death and injury resulting from frontovers.

While Congress mandated in 2008 that NHTSA issue a rule to establish rear visibility standards in response to backover accidents, no similar front visibility standards exist.





### Attorney General

The Ohio Supreme Court is weighing the potential stay of an appeals court decision that reversed a freeze of more than \$8 million in assets which the Ohio Attorney General's Office is seeking to recover from former Public Utilities Commission of Ohio (PUCO) Chairman Sam Randazzo. FirstEnergy has admitted to bribing Randazzo in connection with energy subsidy legislation, 133-HB6 (Callender-Wilkin). The Franklin County Common Pleas Court had granted Attorney General Dave Yost's request to attach millions of dollars of Randazzo's assets before he could shield them from litigation, but the 10th District reversed that order in September. Yost turned to the Ohio Supreme Court, asking justices to stay the 10th District decision to free up Randazzo's assets.

### Automobile Industry

The Biden administration joined Gov. Mike DeWine and U.S. Sen. Sherrod Brown (D-OH) in announcing a \$4.4 billion investment by Honda Motor Co. and LG Energy Solutions of Korea in a new Fayette County electric vehicle (EV) battery plant and another \$700,000 to convert Honda's three existing Ohio automotive factories to EV production by the end of 2026, creating over 2,500 projected new jobs.

Honda and LG Energy Solution's investment of over \$4 billion for electric vehicle production is expected to receive \$156.3 million in state incentives, including an estimated \$71.3 million in expanded Job Creation Tax Credits. Ohio Department of Development (DOD) Chief Communications Officer Todd Walker said the tax credit will be considered at an upcoming meeting of the Ohio Tax Credit Authority (TCA). It is for 1.871 percent over 30 years and is performance-based. That will require fulfillment of job creation and payroll commitments as well as annual reports that verify progress. The project is expected to involve investment of at least \$4.2 billion and creation of over 2,500 jobs. DOD is also working with the General Assembly for state investment of \$85 million in local water and transportation infrastructure upgrades that ensure project success and benefit local communities.

The U.S. Department of Energy (USDOE) announced it would award \$75 million to support an expansion plan that will upgrade Cirba Solutions' existing lithium-ion battery recycling facility to produce battery-grade raw materials. This is part of the first phase in a total of over \$7 billion for battery supply chains through the federal Bipartisan Infrastructure law. According to Cirba, the facility will be able to produce enough battery-grade critical minerals used in cathode production to power more than 200,000 new electric vehicles (EVs) annually. It will also create an estimated 150 new jobs in the Lancaster area and is slated to be one of the largest commercial-scale battery recycling facilities in North America.

Ohio businesses can now begin applying for \$100 million in federal funding for electric vehicle (EV) charging infrastructure, Gov. Mike DeWine and Lt. Gov. Jon Husted announced. ### **Business/Corporate**

The Ohio State University (OSU) and the OSU Wexner Medical Center received the 2022 Governor's Inclusive Employer Award, with Lt. Gov. Jon Husted making the announcement during an event on OSU's campus. The Cleveland Clinic and Meijer were also recognized as "Ohio Inclusive Employers." According to Opportunities for Ohioans with Disabilities (OOD), this award recognizes OSU's and Wexner Medical Center's "commitment to individuals with disabilities in the workplace and being leaders of diversity and inclusion best practices in Ohio."

Calling it the start of a "10-year conversation," Ohio Chamber of Commerce President and CEO Steve Stivers joined other business leaders in releasing a "Blueprint for Ohio's Economic Future" that was prepared by the Ohio Chamber and Accenture. Stivers said Accenture reviewed data on economic competitiveness from many different sources and prepared





policy recommendations for state leaders. "Ohio is not just competing with other states, we are competing in a global economy," he said. "While there is much to be proud of regarding Ohio's efforts to be business friendly, we must take steps now to lay the foundation for future growth in the years to come."

#### **Cities**

With state agencies in the process of submitting their proposed budgets for the next biennium to the governor's office, the Ohio Municipal League (OML) announced priorities that it said will ensure adequate funding of Ohio's cities and villages while also providing for the health, safety and economic prosperity of millions of Ohioans. OML said it has shared its priorities with Gov. Mike DeWine's office as well as Office of Budget and Management Director Kimberly Murnieks and the offices of House Speaker Bob Cupp (R-Lima) and Senate President Matt Huffman (R-Lima). "With Ohio currently being in a strong financial position, we have a great opportunity to continue strengthening the partnership between the state and its municipalities," OML Board President and Troy City Director Patrick Titterington said. "The Ohio Municipal League's priorities for the state operating budget cover a robust list of policy issues that are both helpful and essential to the infrastructure, programs and services provided through municipal government." Restoration of the Local Government Fund continues to be a priority for OML.

### **Economic Development**

U.S. Sens. Sherrod Brown (D-OH) and Rob Portman (R-OH) both announced that five community development entities in Ohio will receive \$230 million through the federal New Markets Tax Credit (NMTC) program, helping attract private investment for their work. The Ohio Community Development Fund in Columbus will receive \$60 million; three entities — the Dayton Region New Market Fund, Northeast Ohio Development Fund in Cleveland and Uptown Consortium in Cincinnati — will each receive \$45 million; and the Cleveland New Markets Investment Fund will receive \$35 million. Ohio groups previously received \$215 million in 2021, according to Brown's office.

### Economy

Moody's Investors Service elevated Ohio's credit outlook to "positive" and affirmed the state's "Aa1" issuer rating, the DeWine administration announced recently. The announcement follows a similar move by Fitch Ratings, which upgraded Ohio's rating to "AAA" from "AA+." The Moody's analysis cites evidence of new economic development that can diversify the state economy.

#### **Education**

The Ohio State Highway Patrol (OSHP) said that over the course of National School Bus Safety Week — which runs from Oct. 17 through Oct. 21 – it increased enforcement efforts on school bus violations, such as passing a stopped school bus, school zone violations and other school bus or school zone-related activity. According to OSHP, National School Bus Safety Week is supported by the National Association for Pupil Transportation and serves as a reminder to motorists, students and school bus drivers of the important role they each have in ensuring children's safety. This year's theme, "1 Bus + 1 Driver = a BIG Impact on Education," reminds motorists and students about the dangers that exist outside the school bus.

Calling it a "success story of collaboration," the Ohio State Highway Patrol and the Ohio departments of transportation (ODOT) and education (ODE) announced a partnership that has created new reflectors for school buses to improve safety for students and motorists. Under the partnership, ODOT will produce new red and black reflective "STOP" decals for the back of school buses that will be put out to school districts for use on the nearly 20,000 school buses used to transport students in the state. Already, nine school districts in the state have participated in a pilot and reported their results to the state. All believed that the new reflective decals were more effective than the standard, non-reflective STOP decal currently displayed on the rear of school buses. Districts that participated in the pilot include Centerville City, Chagrin Falls Exempted Village, Columbus City, Dublin City, Green Local, Huber Heights City, Marysville Exempted Village, Massillon City and Union-Scioto Local schools.





Six Ohio school districts are among nearly 400 across the U.S. to get support for alternative fuel buses under the federal Bipartisan Infrastructure Law. The Biden administration recently announced recipients of federal FY22 Clean School Bus Program rebates from the U.S. Environmental Protection Agency (USEPA). Ohio recipients and funding amounts include the following:

- » \$1,185,000 to Zenith Academy West in Columbus for three electric buses.
- » \$750,000 to Toledo Public Schools for 25 propane buses.
- » \$790,000 to Amanda-Clearcreek Local School in the village of Amanda for two electric buses.
- » \$1,580,000 to Madison-Plains Local Schools District in the city of London for four electric buses.
- » \$790,000 to Bradford Exempted Village School District in the village of Bradford for two electric buses.
- » \$790,000 to Eastern Local School District in the village of Beaver for two electric buses.

### **Energy/Utilities**

Ohio Attorney General Dave Yost says he's "pushing back" on plaintiff attorneys' proposal in the FirstEnergy class action case to pocket 33 percent of the proposed settlement. Plaintiffs' counsel is seeking U.S. District Judge Edmund Sargus's final approval of a \$49 million settlement with FirstEnergy on behalf of ratepayers, of which attorneys are requesting over \$16 million in legal fees. "The settlement table was set by my office and the U.S. Attorney; now these greedy attorneys are sitting down to dine," Yost said in a statement Wednesday afternoon. "FirstEnergy already shook down Ohio ratepayers. Let's not let plaintiff attorneys do the same."

Public Utilities Commission of Ohio (PUCO) Commissioner Daniel Conway sounded the alarm about rising energy prices that left many Ohioans with sticker shock this summer and are on track to more than double next year. Conway seized on this month's FirstEnergy commodity auction for its standard service offer (SSO) to issue an economic primer of sorts on the relationship between historic inflation, natural gas prices and electricity costs. He explained the delayed impact electric auctions have on retail prices many months later. Year-over-year, the FirstEnergy's wholesale cost spiked more than 143 percent to \$122.30 per megawatt hour (MWh) compared to \$50.21 in October 2021. Confirming the inflationary trend, Duke Energy Ohio's electric auction price rose more than 141 percent in late September to \$115.75 MWh compared to \$47.99 MWh in September 2021. PUCO staff had warned commissioners of "uncharted waters" for energy futures earlier this year.

The Office of Ohio Consumers' Counsel (OCC) continues to push for documents and testimony on June 2022 outages affecting tens of thousands of American Electric Power (AEP) of Ohio customers in the capital area. AEP says OCC is merely seeking to conduct its own investigation into potential causes three months after the consumers' counsel asked the Public Utilities Commission of Ohio (PUCO) to do so. OCC is redoubling its argument for discovery and depositions from AEP officials stemming from June 14-15 blackouts, which the company has attributed to heat-related consumption and forced outages to prevent a worse problem.

Residential consumers of Columbia Gas of Ohio would pay 95 percent of the \$68.2 million proposed rate hike agreed to by the Ohio Manufacturers' Association (OMA) and Ohio Consumers' Counsel (OCC) while saving another \$143.8 million in increased charges waived by the company under a settlement with Public Utilities Commission of Ohio (PUCO) staff. The settlement had been scheduled for a hearing and still requires commission approval but boasts a large group of signatories including Industrial Energy Users (IEU) Ohio, Ohio Schools Council (OSC), Interstate Gas Supply (IGS), Northeast Ohio Public Energy Council (NOPEC), Retail Energy Supply Association (RESA) and The Kroger Co., as well as OCC and OMA Energy Group. Columbia, which serves 1.4 million consumers in 60 Ohio counties, will forgo \$102 million plus interest it had hoped to charge regular customers as of Jan. 1, 2023 for demand-side management (DSM), along with another \$10 million in so-called "shared savings." Low-income customers will be assisted by \$15 million collected from all ratepayers — unchanged from 2022 — "meaning there will be no inflationary increases or other increases in what consumers are charged for WarmChoice," PUCO said.





#### **Environment**

The Greater Ohio Policy Center (GOPC) recently released a white paper on "The Benefit of Brownfields" analyzing the Ohio Department of Development's (DOD) awarding of \$252 million during the first round of the Brownfield Remediation Fund. GOPC is also calling for another \$500 million in remediation funding through the next state operating budget. The paper found that 72 percent of the total \$350 million was awarded during the first round, with funds going to 58 counties for 115 clean-up projects and 74 assessments.

Fifty-three public water systems will receive approximately \$2.4 million to take the first step toward removing and replacing lead water pipes, Gov. Mike DeWine and Ohio Environmental Protection Agency (Ohio EPA) Director Laurie Stevenson announced. The 53 lead pipe mapping projects will take place in communities in 37 counties. All applicants are receiving their full funding request of up to \$50,000.

#### Federal

Approximately 70 million Americans will receive an 8.7 percent increase in Social Security and Supplemental Security Income (SSI) in 2023, the U.S. Social Security Administration (SSA) announced. On average, Social Security benefits will increase by more than \$140 per month starting in January, according to the agency. The 8.7 percent cost-of-living adjustment (COLA) will begin with benefits payable to more than 65 million Social Security beneficiaries in January 2023. Increased payments to more than 7 million SSI beneficiaries will begin on Dec. 30, 2022. Some people receive both Social Security and SSI benefits. The Social Security Act ties the annual COLA to the increase in the Consumer Price Index as determined by the U.S. Department of Labor's (DOL) Bureau of Labor Statistics (BLS).

### **Higher Education**

The Ohio Association of Community Colleges (OACC) this week began a new collaboration among its members to fine-tune their training programs so they can teach the exact skills the semiconductor and tech industry looks for in job candidates. The announcement comes as Intel has broken ground on a multibillion-dollar semiconductor plant in Licking County. OACC said its Ohio Semiconductor Collaboration Network Steering Committee leverages the know-how of all 23 community colleges to develop career pathways that will provide the skills training and talent needs of the semiconductor industry in Ohio.

### Housing/Homelessness/Urban Revitalization

The Ohio Department of Development (DOD) announced it would distribute \$20 million in funds to 28 communities, improving affordable housing and providing homeownership and rental assistance for low- and moderate-income families. The Community Housing Impact and Preservation (CHIP) program partners with communities to preserve and improve Ohio's affordable housing stock through a variety of housing-related initiatives that include home renovation and repair as well as rental assistance." This funding will support the ongoing work of local communities to strengthen their neighborhoods and give residents access to a variety of housing options." Lt. Gov. Jon Husted added that as communities increase their workforce, housing and homeownership need to increase as well.

The DeWine administration announced grant awards for the redevelopment of several hundred dilapidated properties in 30 counties. In total, \$37.2 million is being distributed to county land reutilization corporations for 825 projects through the Ohio Building Demolition and Site Revitalization Program, a creation of HB110 (Oelslager) administered by the Ohio Department of Development (DOD). DOD initially awarded funding up to \$500,000 for 87 counties this summer, and an additional \$22.6 million is being awarded to counties that requested more.





#### Intel

The Ohio Tax Credit Authority (TCA) approved assistance for Honda's electric vehicle (EV) project and two other projects, while also updating the percentage rate for Intel's assistance from 3.101 percent to 3.99 percent. The term for Intel's assistance remains 30 years, and the estimated value has increased from \$475 million to \$557.8 million, according to the Ohio Department of Development (DOD). The plan to update the rate had been announced by DOD after the September TCA meeting when the lower rate had been incorrectly approved.

#### Local Government

The Department of Development (DOD) awarded more than \$10.6 million for Neighborhood Revitalization and Critical Infrastructure grants to 20 Ohio communities. These grants will assist communities with neighborhood improvement projects designed to improve the health, safety, and general welfare of residents. Five communities will receive grants for Neighborhood Revitalization totaling \$3.69 million. Eligible activities include public facility improvements, such as construction, reconstruction, or rehabilitation of infrastructure, fire protection facilities and community centers in low-to moderate-income target areas.

### Public Safety

Over a third of \$22.6 million in new Ohio Traffic Safety Office (OTSO) awards are slated for the Ohio State Highway Patrol (OSHP). OTSO is providing roughly 180 grants to more than 140 state and local law enforcement agencies in 68 counties to reduce vehicle crashes and traffic fatalities due to impaired driving, unused seat belts, distracted driving, youthful driving, and motorcycling. Funding includes 10 separate awards to OSHP and two to the Ohio Department of Health (ODH), the state's second biggest traffic safety grantee with \$816,243.

Throughout the month of November, the OSHP is conducting an online survey to identify traffic safety concerns and obtain feedback about interactions with the agency. The 2022 Public Survey is anonymous and takes approximately five minutes to complete. The survey is designed to be used as a platform for organizational learning, asking specific questions related to traffic safety issues and previous interactions with OSHP employees. The survey is created in accordance with standards of the Commission on Accreditation for Law Enforcement Agencies (CALEA). OSHP is committed to providing professional law enforcement services focused on deterring crime and promoting traffic safety to improve the quality of life for the citizens and visitors of Ohio. To do that, they encourage the public to take their survey.

The Ohio Peace Officer Training Academy (OPOTA) announced \$280,000 in federal funding Thursday for law enforcement training to identify impaired drivers and investigate traffic collisions. Traffic Safety and Impaired Driving Training Grants will reimburse tuition for Ohio law enforcement officers attending the following OPOTA courses such as Advanced Roadside Impaired Driving Enforcement (ARIDE), Standardized Field Sobriety Testing Instructor and Advanced Traffic Collision Investigation.

### Technology/Aerospace

While Advanced Drainage Systems' (ADS) new engineering and technology center will bring 200 new jobs and \$20 million in added payroll to Hilliard, Lt. Gov. Jon Husted and other speakers at a groundbreaking ceremony also stressed environmental benefits of its stormwater management products and use of recycled plastic in manufacturing. The center is scheduled to open in late 2023. Husted said the ADS center will require more engineering and STEM talent, specifically chemical engineers and computer science professionals to run modeling and research.





### Transportation/Infrastructure

The U.S. Department of Transportation's Federal Highway Administration (FHWA) released its FY23 apportionments for 12 formula programs receiving funding from the Bipartisan Infrastructure Law (BIL). According to U.S. Reps. Marcy Kaptur (D-Toledo) and Tim Ryan (D-Niles), Ohio is set to get about \$2 billion in funding from the bill, citing data from FHWA. The legislators said Ohio will have flexibility in determining how the federal funding will be deployed. The funding will be broken down as follows:

- » Surface Transportation Block Grant: \$471,914,429
- » Highway Safety Improvement Program: \$100,590,011
- » Railway-Highway Crossings Program: \$9,406,315
- » Congestion Mitigation & Air Quality Program: \$106,421,845

- » National Highway Freight Program: \$47,416,042
- » Carbon Reduction Program: \$42,079,036
- » PROTECT Formula Program: \$47,846,880
- » National Electric Vehicle Infrastructure Program: \$29,844,883
- » Appalachian Development Highway System: \$19,369,573
- » Bridge Formula Program: \$104,290,441
