Initiated in 2015

Purpose

To promote water trails in Central Ohio


Objectives

- Assess 92 miles of proposed Blueways
- Increase use and knowledge of Central Ohio's water trails and water resources

Tasks and Deliverables

- Evaluate and prioritize access points
- Blueways mapping (access, hazards, etc.)
- Develop logo and branding/signage
- Create educational information





ORIGIN

Debuted in 2018


Features

- Online mapping of access points
- Water safety
- Boat registration
- Protection of waterways
- Links to water levels

Coverage

- Big Darby Creek (Scioto Darby Road to Orient)
- Scioto River (O'Shaughnessy Dam to Rickenbacker)
- Olentangy River (Delaware Dam to Scioto River)
- Alum Creek (Alum Creek Reservoir to Three Creeks/Big Walnut Creek)
- Big Walnut Creek (Hoover Dam to Rickenbacker)






CURRENT FOCUS

Develop a program that promotes waterways as a resource in Central Ohio for accessible and equitable recreation and natural environment experiences.

How?

- Water Trail Designation
- Update mapping
- Wayfinding and signage
- Access point best practices
- Connections to points of interest
- Synchronize access





WATER TRAIL DESIGNATION

- Through Ohio Department of Natural Resources (ODNR)
- Requires Partnership Agreements
- Need Access Point Inventory
 - Including Amenities
- Opportunities for Funding
 - Brochures
 - Maps
 - Signage
- Olentangy River received Water Trail Designation
 - Broadmeadows to the Downtown Confluence






UPDATE MAPPING

- Hazards

Needs

- Updating and filling in blanks
- ADA accessibility
- Storage
- Trail access
- Potable water
- Etc.





AFTER THAT?

Wayfinding Plan

- On and off water signage
- Tied into COG Wayfinding
- Include nearby points of interest

Opportunities for Improved Access

- Upgrading primitive access points
- ADA accessibility
- Boat slides
- Best practices


Integrating with the Community
