Mr. Crosier further explained that there had been some project delays related to fiber relocation, and that the demolition of the pedestrian bridge was now expected to occur the last weekend in October.

Mr. Crosier informed the board the FCTID was successful in receiving a \$250,000 grant from ODOT Jobs and Commerce for the University Boulevard Project.

Mr. Crosier informed the board that FCEO staff had been preparing a MORPC Attributable Funding Application for the SR 161 at Linworth Road Improvements Project. Mr. Graham informed the board that a resolution would need to be passed to authorize submittal of a MORPC Attributable Funding Application.

RESOLUTION DESIGNATING TRANSPORTATION IMPROVEMENT PROJECT, TO WIT: ROHR ROAD CORRIDOR IMPROVEMENTS PROJECT; APPROVING AMENDMENT OF INTERGOVERNMENTAL AGREEMENT AND RELATED ACTIONS

**WHEREAS,** the Franklin County Transportation Improvement District (the "FCTID") is authorized by ORC Chapter 5540 (1) to finance, construct, maintain, repair, and operate street, highway, and other transportation projects (including, but not limited to, bike/pedestrian, parking facilities, air and rail projects); and (2) to construct, reconstruct, improve, alter, and repair roads, highways, public places, buildings, and other infrastructure;

WHEREAS, the transportation projects undertaken by the FCTID and exercise of its authority, pursuant to ORC Chapter 5540, are considered to be essential and to contribute to the improvement of the prosperity, health, safety, and welfare of the people of Franklin County, Ohio (the "County"), various local political subdivisions located within the County, the region and the State of Ohio (the "State"), and are essential governmental functions that will also promote industry, commerce, distribution, and research activity within the County, the region and the State;

WHEREAS, it is also envisioned and intended that the ongoing efforts of the FCTID will assist and provide greater efficiencies to the ongoing transportation infrastructure and related improvement efforts in the County, and in relationship and coordination with the Ohio Department of Transportation ("ODOT"), the Ohio Development Services Agency ("DSA"), Mid-Ohio Regional Planning Commission ("MORPC"), Ohio Public Works Commission ("OPWC") and various other local political subdivisions and other agencies and offices within the County, including, but not limited to, the Franklin County Engineer's Office ("FCEO"),the Franklin County Department of Economic Development & Planning ("FCEDP") and the Franklin County Department of Public Facilities Management (PFM), and the business community, and neighboring communities and counties, as applicable or appropriate, in advancing transportation improvements, and related economic development and job retention and creation, which is vital to the long term mobility and economic prosperity of the County, the local political subdivisions within the County, the region and the State and their people;

WHEREAS, the FCTID, consistent with its purpose and mission, including the designation and development of projects as designated by its Board of Trustees under ORC Chapter 5540, empowers the various political subdivisions within the County, to participate in a cooperative county-wide coalition to take advantage of the opportunities and benefits made available through a Transportation Improvement District to plan, fund, construct and improve highways, roads, bridges, interchanges, parking facilities and other transportation improvements and accompanying capital improvements and development throughout the County and its environs, utilizing a program-level development approach for integration of local transportation

projects, and which program of transportation projects referred to as the "FCTID Program of Projects", as further set forth, developed and described on documents on file with the FCTID and FCEO, is intended to be amended and supplemented as appropriate to add additional projects, from time to time, as feasible and appropriate;

WHEREAS, the FCTID now intends to add to the FCTID Program of Projects the following transportation improvement project known as the *Rohr Road Corridor Improvements Project*, a collaborative project between the FCTID, the County, the Village of Obetz, and the City of Columbus, with the potential participation of a private developer, for the improvements to Rohr Road from Lockbourne Road to Alum Creek Drive, as well as related intersections, in such phases as determined appropriate and feasible by the FCTID and FCEO, and as further set forth, developed and described and in accordance with documents and plans on file with the FCEO, and FCTID, and to provide project management and construction services which are to be administered and co-managed in cooperation and conjunction with the FCEO and funded with available revenues pledged to the FCTID from state or local governments, private funding sources or other identified available funding sources (referred to hereafter as the "Rohr Road Corridor Improvements Project");

**WHEREAS,** the County and the FCTID, to further develop, facilitate, enhance, fund and promote transportation improvements within the County and the region, through intergovernmental cooperation and coordination by the FCTID and to advance the FCTID Program of Projects, entered into an intergovernmental agreement on file with the FCTID and the County, dated and entered into on November 26, 2019 (the "IGA");

**WHEREAS,** the County and the FCTID, in furtherance of these goals, intend, pursuant to Section 1.02 (a) of the IGA, to approve and authorize an updated and amended Exhibit A "Identified Projects - Franklin County Transportation Improvement District Program List – November 2020", attached hereto and referred to as "Exhibit A" to the IGA, to reflect this additional project referenced above; and,

**NOW, THEREFORE, BE IT RESOLVED** that the FCTID Board of Trustees (the "Board") does hereby designate and adds to the FCTID Program of Projects the *Rohr Road Corridor Improvements Projects*, in accordance with and pursuant to ORC Sections 5540.01 (C), 5540.02 (F), 5540.03 (A) (4), (8) and (10) and related sections and FCTID Resolution 2019-02.

**BE IT FURTHER RESOLVED** that the Board approves and authorizes updated and amended Exhibit A to the IGA, in substantially the form attached hereto with only such changes as determined by the FCTID Secretary-Treasurer in consultation with FCTID Legal Counsel to not be materially adverse to the FCTID, and which Exhibit A is to be substituted for any prior versions by the FCTID Secretary-Treasurer, contingent upon reciprocal approval by the Franklin County Board of Commissioners, and that the taking of any such action and the execution and delivery of any related documents, agreements or instruments, including amended Exhibit A to the IGA with the County or other cooperative agreements with implementation partners, by the FCTID Secretary-Treasurer shall be conclusive evidence of the Board's determination that such actions are proper, authorized, approved and necessary in order for the FCTID to carry out the purposes of this resolution and of the authorization thereof by the Board.

It is found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board, and that all deliberations of this Board that resulted in such formal action, were in meetings open to the public, in compliance with the law, including Section 121.22 of the Ohio Revised Code.

# FRANKLIN COUNTY TRANSPORTATION IMPROVEMENT DISTRICT'S ANTIRACISM & EQUITY PROGRAM

July 23, 2020

The Franklin County Transportation Improvement District denounces racism in all forms. More needs to be done now. We pledge to listen and continue to learn more from those affected by racism, and we will strive to promote meaningful and lasting change in our organization, Franklin County, and society at large.

# Franklin County Transportation Improvement District's Antiracism & Equity Program

The Franklin County Transportation Improvement District (FCTID) was created in March 2019 by the Franklin County Board of Commissioners. The district was established at the request of Franklin County Engineer Cornell R. Robertson, P.E., P.S. and with the support of regional transportation, mobility, and public safety partners. The Mid-Ohio Regional Planning Commission (MORPC) provides administrative services to the FCTID. It is an organization that advances multijurisdictional and economic development-related transportation improvements. Authorized by the Ohio Revised Code Chapter 5540, Transportation Improvement Districts (TIDs) promote intergovernmental and public-private cooperation of transportation resources and investments.

The FCTID supports the Franklin County Board of Commissioners' Declaration of Racism as a Public Health Crisis and will work to eliminate racism, discrimination, and social injustice through diversity, inclusion and equity initiatives. This intentional and purposeful approach will be a top priority, and it will support our commitment to work to eradicate racism as we collaborate with vendors, suppliers, consultants, and contractors to make infrastructure improvements in Franklin County.

Therefore, the Franklin County Transportation Improvement District has established the Franklin County Transportation Improvement District's Antiracism & Equity Program (FCTID AEP), which contains specific, positive, measureable action items to explicitly and publicly affirm our identity as an anti-racist organization as we collaborate with vendors, suppliers, consultants, contractors and all other individuals or entities conducting business with the FCTID. As an antiracist organization, we pledge to purposefully identify, discuss, and challenge ourselves to understand and correct any inequities we may discover, and gain a better understanding of ourselves during this purposeful process with everyone in Franklin County that we conduct business with or serve whether they be vendors, suppliers, consultants, contractors, residents, citizens, constituents, those who work in Franklin County but live elsewhere, or those just traveling through Franklin County. The Franklin County Improvement District will use this document to develop relationships of solidarity, support, and trust rooted in intentional antiracist thought, action, and reflection.

The FCTID AEP was created after receiving input from various members of the FCTID. To be intentional and purposeful, we will evaluate the action items of the FCTID AEP on a quarterly basis to ascertain if we are meeting our goals and objectives and will revise the program as needed. We will also conduct open discussions and facilitate a constant dialogue regarding healthy racial relations with the members of our organization.

The FCTID considers diversity to mean acknowledging, understanding, accepting, celebrating and valuing the uniqueness of all individuals. Each person is an individual with visible and non-visible differences, and by respecting this, everyone can feel valued for their contributions, which is beneficial not only for the individual but for the FCTID as well. Inclusion is the intentional act of embracing diversity and establishing a culture where each uniquely different person is provided the opportunity to thrive, succeed and excel. Diversity is what you have.....Inclusion is what you do.

Equity helps everyone to recognize that advantages and barriers exist, and that, as a result, we do not all have the same starting point. Equity is an approach that ensures everyone has access to the same opportunities. Equity is a process that begins by acknowledging the unequal starting place and continues by addressing and correcting the imbalance.

# **Vendors, Suppliers, Consultants, Contractors**

The FCTID will support the Franklin County Board of Commissioners' work to progress as an equitable and fair-minded organization, with leadership continuing to identify specific activities to further enhance diversity, inclusion and equity, and to ensure antiracism principles for vendors, suppliers, consultants, and contractors. All people interacting or doing business with the FCTID shall adhere to the terms of this program and have a business model or network that is compatible with the FCTID AEP. The FCTID adheres to the latest design and construction standards enacted by the State of Ohio and City of Columbus for the maintenance and improvement of roads, bridges, infrastructure for multiple modes of transportation, utilities, and drainage facilities. We want our business partners to be reliable, reputable and productive so we can deliver the best services to the community, and we need diversity to help us achieve this. The collaboration of diverse populations will lend itself to the best possible outcomes for our business partners and the community.

**WE AFFIRM** that the FCTID is committed to promoting diversity, inclusion, and equity in all aspects of the organization. This commitment the will be supported by utilizing the Franklin County Engineer's Equitable Business Enterprise (FCE EBE) Program for Locally Funded Projects, which was implemented on May 4, 2020, as a guide when administering current and future projects. The FCE EBE Program (Attachment A) will continue into the future. Checks and interviews will be conducted in-the-field to verify compliance.

**WE AFFIRM** that the FCTID will provide guidance to help disadvantaged businesses navigate the certification process by connecting them with the tools and resources available to achieve their goals and objectives. This can be accomplished by sending notification of upcoming trainings, workshops and/or events to minority owned businesses through minority owned publications, email, U.S. mail, text messages and/or telephone calls, open houses, or in-person meetings with our organization.

**WE AFFIRM** to be intentional in notifying minority owned business of opportunities with the FCTID. This can be accomplished by sending notification of projects or events to minority owned businesses through minority owned publications, email, US mail, text messages and/or telephone calls, open houses, or in-person meetings with our organization.

**WE AFFIRM** to designate a specific date to celebrate minority engineers and/or other minority professionals or employees that have made a significant contribution to the industry. This celebration may consist of announcements on social media platforms, acknowledgement through plaques, trophies, proclamations, or other gestures of appreciation, award luncheons, etc.

# **Community Outreach & Public Engagement**

The Franklin County Improvement District will work to implement strategies that dismantle racism within our community and society at large. Diverse outreach will allow the FCTID to make positive contributions to the communities of Franklin County in an impactful and meaningful manner.

**WE AFFIRM** that through our commitment to diversity, inclusion and equity, we will provide opportunities for underrepresented populations to share their ideas, suggestions and perspectives regarding planning, programs and projects for Franklin County. This can be accomplished by hosting public meetings, soliciting input through surveys, letters, emails and text messages, and holding open houses for residents to voice their input in an informal setting.

**WE AFFIRM** that the FCTID will support the Small Governments Infrastructure Improvement Funding (SGIIF) administered by the Franklin County Engineer's Office to small governments to improve roads, bridges, and infrastructure for multiple modes of transportation in an equitable way for all citizens, constituents, residents, and traveling public within Franklin County. The 2020 SGIIF will be utilized to resurface various roads in need of repair in the Village of Harrisburg and the Village of Urbancrest.

**WE AFFIRM** to utilize translation and interpreting services when necessary to ensure residents from varying backgrounds can communicate with the FCTID members and/or representatives so they are informed about the FCTID projects and/or events.

**WE AFFIRM** to focus on projects that have elements of First Mile/Last Mile in areas of Franklin County that need to provide transportation systems in underrepresented communities. Currently under construction or design:

- Cassady Avenue road, pedestrian facilities, and drainage improvements
- Cleveland Avenue from Huy Road to Elmore Road
- Cooke Road Corridor Study
- Ferris Road Corridor Study





# **FCTID RECEIVES ODOT JOBS & COMMERCE GRANT**

The Franklin County Transportation Improvement District has been awarded a \$250,000 grant for construction of the University Boulevard Project in the City of Dublin. This project is the result of collaboration between the FCTID, the Franklin County Engineer's Office, the City of Dublin, and The Ohio State University. The University Boulevard Project will construct a new roadway between Eiterman Road and Avery Road, and it will also improve the intersection of Shier Rings Road and Avery Road. This project will support the development of a new comprehensive ambulatory medical facility, which will create 350 new jobs in the region.

# **APPLICATION FOR MORPC-ATTRIBUTABLE FUNDS**

The FCTID, in collaboration with the Franklin County Engineer's Office, the City of Columbus, the City of Worthington, and Perry Township, has submitted an attributable funding application to MORPC for the SR 161 and Linworth Road Improvements Project. The FCTID is requesting \$7,138,600 to facilitate the construction of new turn lanes, as well as the extension of existing turn lanes, at the intersection. The project also intends to add a multi-use path along the project limits.

# ALEX BERES LEAVES FCTID TO ACCEPT POSITION WITH USDOT

Alex Beres resigned as Secretary-Treasurer of the FCTID on September 25, 2020 to accept a position as a Senior Policy Analyst with the United States Department of Transportation's Office of Infrastructure Finance and Innovation in Washington D.C. Alex was integral in the successful creation of the FCTID, and he had served on this board since the FCTID's inception. We thank him for his dedicated service to the TID and wish him the best of luck in his new position.

# PEDESTRIAN BRIDGE OVER HIGH STREET DEMOLISHED

The FCTID, on behalf of the Franklin County Board of Commissioners, demolished the pedestrian bridge previously located over South High Street, between Fulton Street and Mound Street on Saturday, Nov. 7, 2020.

Demolition of the pedestrian bridge was the first phase of the FCTID's Franklin County Parking Facilities Improvement Project, which aims to maintain and improve access to parking facilities associated with Franklin County's Downtown Complex (34 East Fulton Street, 373 South High Street, and 399 South Front Street). The total project cost was \$923,958, and the bridge demolition work was completed by Corna Kokosing.

The Franklin County Parking Facilities Improvement Project is one of the first projects implemented by the FCTID since the board was created in the spring of 2019. Future phases of this project will aim to minimize construction impacts to Franklin County parking facilities related to the ongoing Columbus Crossroads project.
