PROJECT FUNDING UPDATES

The Franklin County Transportation Improvement District applied for MORPC Attributable Funding for the SR-161 at Linworth Road Improvements Project in the Fall of 2020. This application was successful, and the project was awarded \$7,138,600 for right-of-way and construction activities. Construction of this project is planned for SFY 2026. The Franklin County Engineer's Office also applied for MORPC Attributable Funding for the East Cooke Road Phase 1 project, which is part of the FCTID Cooke Road Corridor Project. This application was successful, and the project was awarded \$2,446,519 for right-of-way and construction activities. Construction of this projects is planned for SFY 2026.

The Franklin County Engineer's Office applied for OPWC assistance for the SR 317 at Lockbourne Road Improvements Project, and the Morse Road at Babbit Road Roundabout, which is a part of the FCTID Morse Road Corridor Project. The SR 317 at Lockbourne Road Improvements Project was awarded \$92,613, and the Morse Road at Babbit Road Roundabout was awarded \$1,257,750. These awards are for construction activities in SFY 2022.


NEW FCTID PROGRAM OF PROJECTS WEB MAP IS AVAILABLE
