# MORPC Cyber Security Working Group

## Impact Statement:

Collect and curate federal and state cybersecurity programs, resources, and information and make information available to MORPC members. Leverage MORPC's contacts with key leaders in Central Ohio government to increase members cyber threat awareness and understanding of available resources and services. Encourage member self-assessment followed by further engagement with state and federal cybersecurity resources. Encourage local collaboration and sharing of knowledge.

## Next Steps:

1. Collect and Curate state and federal cybersecurity information, resources, and programs.
2. Conduct MORPC Cybersecurity Seminar for key member leaders providing threat information, best practices, and programs/information/ resources available to them.
3. Provide self-assessment materials and encourage members to conduct the assessment.
4. Evaluate the assessment and encourage engagement with available state and federal resources to improve cybersecurity.
5. Evaluate impact of efforts and improvements made.
6. Work to influence vendors to meet standards in cybersecurity.

## SMART Goals:

1. Complete Collection and Curation of information by June 30, 2024
2. Conduct Cyber Security Seminar by July 30, 2024, with greater than 90% member attendance.
3. Start self-assessments by August 15, 2024, and complete by September 30, 2024, with 75% member completion.
4. Poll members to determine % engaged with state and federal programs to improve cyber posture. Goal is 75% by December 1, 2024.
5. Have requirements in place to enforce 100% vender compliance with NIST standards for new contracts by January 1, 2025.
