### 1. Pledge of Allegiance

**SUBJECT:** Requests for Exceptions to Delinquent Projects Policy

District 3 has a policy to encourage funding recipients to complete construction and close out projects with OPWC without undue delay. A project that does not begin construction and close out in a timely fashion is considered delinquent. Consequently, the sponsoring agency of a delinquent project is not eligible to receive full credit for Criterion S10 on its current applications for FY26.

If circumstances outside an applicant's control significantly delay the construction schedule for a project, including delays attributable to the use of federal funds, the PWIC may approve an exception. The PWIC will take action on these requests at the next meeting on October 18.

The table below summarizes projects that are considered delinquent from sponsoring agencies that have requested an exception for FY26 (Round 39) applications.

### CC16W/CC17W - City of New Albany - US 62 @ SR 161 Roadway Improvements (Round 33):

This project was an LPA administered through ODOT District 6. PRIME Construction Management and Survey provided project administration, inspection, and materials testing on behalf of the City of New Albany. In addition to OPWC funding, the project received federal safety funds administered through ODOT. This slowed down the design development and construction process substantially. Construction of this project also occurred concurrently with the construction of the adjacent ODOT FRA-161-15.80 infrastructure improvements project. There was considerable overlap between the projects, particularly on and around the FRA-161-21.73 L&R overpass and the associated on/off ramps to/from US-62. The ODOT project performed substantial work on the bridge and ramps, which required heavy coordination and resequencing of construction to keep both projects moving smoothly. At this time, the project is at final completion.

# CC27X/CC28X – City of New Albany – US 62/SR 605 Bypass-Market Street Extension (Round 34):

The design development and contract procurement for construction were delayed largely due to right-of-way constraints. The process for the procurement of right-of-way took longer than expected as a significant portion of the project was dependent upon the donation of land by the Wexner Estate, for the alignment between SR-605 and Dublin-Granville Rd. The vetting process for right-of-way acquisition on the Wexner Estate was substantial, due to security and aesthetic concerns by the owner. There was also a substantial amount of right-of-way that required acquisition at the intersection of 3<sup>rd</sup> Street and US-62. The landowners in this location were agreeable to donating the right-of-way to the City, however, they required a robust legal review and land acquisition agreement that slowed down the project development significantly. The bid for construction of this project was opened Friday, September 6 and award is anticipated to the lowest and best bidder within the next week. Construction will begin as soon as possible after award. Throughout the process of design development and right-of-way acquisition, the City had regularly been in touch with Jennifer Kline of OPWC and the continued delays were communicated. OPWC has granted the City an extension until October 31, 2025.

### CC19AA /CC20AA - City of Grove City - Columbus Street Improvements (Round 37):

The City of Grove City is requesting an exemption for the Columbus Street Improvements project. This project was awarded funding in FY24 (Round 37). The project received additional funding through the Ohio EPA Water Pollution Control Loan Fund (WPCLF). The loan was not awarded until September 26. The city opened bids for the project on August 10 and issued a notice of intent to award to the Ruhlin Company.

### Franklin County Sanitary Engineer's Projects

**North Hague Avenue Sanitary Sewer Collections System-** this project was let for bid on July 10th and bids were received on August 30th. The Department is currently evaluating the lowest and most responsive bid and anticipates that the construction contract will be before the Commissioners at their November 5th Meeting. The contract allows for a construction period of approximately 10 months, whereby it is anticipated that this project will be complete in or about September 2025.

Ferris Avenue Sanitary Sewer Collections System- this project has experienced considerable delays, due largely and most recently to the need to acquire an easement from the City of Columbus. To further complicate matters, the Ohio Department of Transportation has an existing easement in the same area that the County needs an easement. As you can imagine, trying to coordinate an easement between the City of Columbus and the Ohio Department of Transportation has added a considerable amount of time to the project. It is anticipated that this easement will be finalized towards the end of 2024 or the beginning of 2025. Accordingly, it is forecasted that the project will be let for bid during the first quarter of 2025 and will likely be completed by the end of 2025.

South Grenner Avenue Sanitary Sewer Improvement Project- you may recall that the Department has let this project for bid on several previous occasions and had to "reject all bids" as they did not come within ten percent of the engineer's estimate, which has added considerable delay to the project. Additionally, the infrastructure in this area is very deep, which adds significant expense and limits the contractors who are able to perform such work. With that said, this project was let for bid on June 25th and bids were received on August 1st. The Department is currently reviewing the bids and anticipates that a contract will be before the Commissioners at their October 22nd Meeting. The construction contract allows ninety days for "Substantial Completion," whereby this project should be completed during the first or second quarter of 2025.
