



Figure F. 1 Projected Population, Households, and Jobs Growth Source: MORPC Forecasts







Figure F. 5 Share of Population Identifying as Hispanic or Latino, 2010 & 2021





Figure F. 7 Percent of Population* with Denoted Disabilities by County, 2021




POPULATION IN POVERTY

Figure F. 8 Percent of Population under 100% Federal Poverty Line, 2010 & 2021





Figure F. 10 Total Employment Trend, 2021-2050








Figure F. 13 Share of Employment by Industry, 2021

Figure F. 14 Total Household Trend, 2021-2050






Figure F. 15 Household Size, 2010 & 2021

HOUSEHOLD INCOME


Figure F. 16 Median Household Income, 2010 & 2021 (Inflation Adjusted to 2021 Dollars)



Figure F. 17 Total Residential Building Permits Issued, 2015-2021





Figure F. 20 Housing Tenure by County, 2010 & 2021





Figure F. 21 Commuting Pattern for Workers who Live in Fairfield County, 2020








Figure F. 23 State & CORPO Mean Commute Times, 2010 & 2021

Figure F. 24 Percent of Households with No Vehicle, 2010 & 2021



Figure F. 25 Fairfield County Sum of Lane Miles by Functional Classification, 2023



Figure F. 26 Fairfield County Roadway Functional Classification, 2022





Figure F. 27 Fairfield County VMT by Year, 2013-2022






Figure F. 29 2022 Fairfield County VMT by Functional Classification

Figure F. 32 Fairfield County AM Peak Congestion, 2023






Figure F. 33 Fairfield County PM Peak Congestion, 2023
