**1. Pledge of Allegiance**

The meeting was called to order at 1:30 p.m. and Darryl Hughes led the committee in the Pledge of Allegiance.

**SUBJECT:** Request to Modify One Previous Project

District 3 has received a request on behalf of Pleasant Township to modify the project limits of one project which applied for SFY 25 funding. The PWIC will consider this request at its meeting on December 6, 2024.

The district ranked Pleasant Township's Timberlake Subdivision Resurfacing Project as the 13<sup>th</sup> ranked LTIP application in the SFY 25 funding round. The original application scope included a total project cost of \$1,203,334 and requested \$958,039 from the LTIP program.

At the time of approving ranking slates, the district's LTIP allocation did not provide enough funding to award funds to this project, but between December of 2023 and June of 2024 a significant amount of funding was returned to the district from prior project closeouts. At the end of June 2024, \$130,949 of LTIP funding was available to offer a partial award to the Timberlake Subdivision Resurfacing Project.

Pleasant Township is requesting that the scope of their project be reduced to accommodate the partial funding award. The reduced scope is attached to this memo. The revised request provides 30% match to the OPWC funds, as opposed to the 20% match in their original application. Additionally, no unfunded project remains beneath this project on the SFY 25 LTIP slate.

Staff are recommending approval of this request for the reasons listed above.
