SECTION 5310 OVERVIEW



- Capital and operating grants for public transportation services to meet the mobility needs of seniors and individuals with disabilities
- Example projects:
 - Purchase of replacement vehicles
 - Contracted transportation
 - Preventive maintenance
- \$8.5 million in Section 5310 funding has been competitively awarded by MORPC since 2019



2024-2025 SECTION 5310 FUNDING CYCLE



MORPC

December 2024

- TIP amendment review and approval (CAC, TAC, TPC)

January 2025

- STIP amendment approval from FTA

February 2025

- Grant submittal to FTA, funding agreements finalized

- \$1,760,329 in federal funds available for the 2024 cycle.
 - Will require a 20% local match.
- Requests for 37 projects from 18 applicants with a total of \$5,120,035 in funds.
- We are recommending 15 applicants receive funding for 18 projects.
 - Federal: \$1,760,329
 - Local: \$650,614
 - **Total: \$2,410,943**



2024 RECOMMENDED PROJECTS

- **Preventative Maintenance:**
 - Canal Winchester Human Services, Clintonville-Beechwold Community Resource Center, Delaware County Transit, LifeCare Alliance, Netcare Corporation, Open Door Columbus (6 requests)
- **Contracted Transportation:**
 - City of Dublin, City of Hilliard, City of Reynoldsburg, Clintonville-Beechwold Community Resource Center, COTA, SourcePoint, St. Vincent Family Services (7 requests)
- **Vehicle Purchase (expansion, vans):**
 - City of Groveport, Tristar Transportation (2 requests)
- **Mobility Management:**
 - Delaware County Transit, MORPC (2 requests)
