4. Greenway Planning Studio Fellowship

The Easton Fellowship will evolve into the Greenway Planning Studio Fellowship, with plans to involve other funders and curate the scope of work for students to align with Regional Trail Vision and local community priorities. Melinda asked for feedback on the scope of work for the students and mentioned the importance of collaboration to ensure the students have a meaningful and productive experience.

5. Hilliard Technical Assistance

• Hilliard's participation in the Technical Assistance Program will kick off in early February.

6. Experience Columbus / Trail Pass Itineraries

- Michelle Wilson, Experience Columbus, reported that there were 2,038 free downloads and 13,192 check-ins in 2024
- MORPC's COG Intern Morgan Fuller will be interfacing with Experience Columbus and with communities to develop and update new and existing itineraries.
- Member Kauffman noted that the Cities of Mt. Vernon, London, and Westerville may be the next three itineraries to be created. Melinda added that MORPC may work with the City of Hilliard to create an itinerary as part of their upcoming Technical Assistance Program participation.
- 2025 Itinerary Goals
 - Market to Market upgrade/update
 - City of London
 - City of Mt. Vernon
 - City of Westerville
 - City of Columbus / Library / Underground Railroad Itinerary though this may go into 2026.
- MORPC staff will send spreadsheets to Experience Columbus by February 14, 2025.
- The new itineraries will launch April 1, as the current itineraries expire March 31.
