#### Trail Expansion

Addition of approximately 240 miles of trails to the regional vision, expanding the footprint from seven counties to a 15-county region.

A goal for 2025 is to add Gateways of Regional Significance to the Vision Map, which are major trailheads with amenities that connect people to nearby towns or activity centers. Interactive Map:

#### **Goal Setting / Priority Projects**

Greenway Planning Studio Workshops will be by corridor this year rather than by quadrant – we will meet with the communities along these priority corridors:

- Dublin to Indian Lake
- Heritage trail extensions
- Buckeye Lake to Pickaway County
- Silicone Heartland Trail / Intel area that connects Sunbury, Johnstown and Centerburg.
- Buckeye Lake to Pickerington
- Scioto Trail from Marion to Chillicothe

#### 2025 Central Ohio Greenways Forums

Member Rayburn volunteered to speak on Dublin's Signature Trail at a COG Forum in mid-/late-2025.
