#### Meeting Called to Order at 1:02 pm.

#### Welcome & Introductions

Two New RDAC Members introduced themselves: Brandon Brown, City of Dublin, and Dr. Ayaz Hyder, Smart Columbus

#### Member & Sector Updates

Member Oliver mentioned a new AI commercial toolkit data management product from Expedia.

Member McCullough raised concerns about the dysfunctional talent market, emphasizing the need for better pathways and roles for data professionals in the region. He also highlighted obstacles such as matchmaking, awareness, and the need for better-defined roles in the evolving landscape of data analytics and AI.

Member Hyder discussed the need for workforce upskilling health and human services professionals to use technology and data, and the potential for partnerships with higher education institutions. This is being addressed by the CIE Initiative. Member Hyder also shared information about Smart Columbus convening a Data and Innovation Leaders Group for Health and Human Services, aimed at improving health, well-being, and equity in Franklin County and Columbus.

Member Brown noted that he attended the GOV AI Summit in December 2025. The group is an excellent resource for civic agencies.

Chair Drummond announced that Metrolab has posted a grant opportunity thru NSF Civic Data Challenge.

Member Knox raised concerns about potential threats to census data programs including funding cuts, making survey responses optional, and limiting contact with respondents. He suggested the possibility of a joint response to advocate for these programs, noting the impact on data quality and availability. The Committee discussed the importance of census data for various organizations and the need for coordinated advocacy efforts to protect these programs. Chair Drummond asked that staff follow up with an email to Members regarding letters of support.

#### **MORPC Updates**

Jessica Kuenzli reminded Members to respond to the Leaders Listen: Economic Development Survey, to register for the February 5 Data Day event, and to register for the March 21 State of the Region event. She also announced that RDAC Members and Working Group Members will be able to attend MORPC events at Commission Member Rates in 2025.

Amanda McEldowney announced that MORPC is looking for sponsors for both Data Day and the State of the Region events. If an organization is interested in sponsoring both, MORPC has sponsorship packages for many of its events.

#### Working Group & User Group Discussion

Cybersecurity Working Group

A total of 18 organizations were represented in-person at the "Cybersecurity for Local Leaders" event, and of those, five have submitted interest forms requesting to engage with the Working Group on their cyber efforts.

Staff asked for ideas from RDAC Members on how to increase engagement from member communities. Suggestions:

- Make the cybersecurity assistance similar to Sustainable2050 and Technical Assistance programs.
- Change the term "assessment" to something else; cybersecurity problems are usually confidential.
- In the future, communities that have been helped by the Cybersecurity Working Group can be ambassadors and share their experience.
- The Ohio Cyber Reserve and Cyber Ohio both are offering services currently.

#### Data Day Working Group

The Working Group continues to plan for Data Day 2025. The location for the event has been secured. Proposals were received at the end of November, and the Working Group has evaluated the proposals and organized them into four tracks for the event. Staff asked that RDAC Members consider sponsoring or asking other organizations to sponsor.

Staff is also hoping to recruit more members for the Working Group; there is currently only one active member.

#### DEI & Data Working Group

The Working Group has submitted two proposals for DEI-centered presentations at Data Day 2025. Working Group efforts are currently focused on supporting Group Members preparing content around the topics environmental justice analysis methods and using data to lead successful transformation.

Staff asked RDAC Members for 2025 project ideas for the Working Group. Suggestions:

- Contacting non-data practitioners who are engaged with data. Examples would be the healthcare, energy, and manufacturing.
- Defining barriers.

An informal show of hands indicated that RDAC Members thought the Working Group should investigate system-level barriers and solutions or organization-type barriers and solutions. The show of online and in-person hands was split evenly between the two ideas.

#### Regional Data Coaches Working Group

The Working Group plans to launch two distinct Office 365 lists, "Regional Data Coaches" and "Regional GIS Coaches" at Data Day, with sign-ups managed via a Microsoft Office form. The Group hosted a pop-up event at the Columbus Metropolitan Library on December 7.

#### Workforce & Job Quality Working Group

The Working Group selected dimensions of job quality most pertinent to the region, and several standards in each dimension. The Group is also wrapping up the planning/education phase of the Results for America Job Quality Fellowship and has been selected to participate in the sixmonth implementation phase starting in January.

#### Central Ohio GIS User Group

The Group met on November 20. Regional updates were provided and Andrew Wilson, City of Hilliard, gave an excellent presentation on tips and tricks in ArcPro.

#### Regional Information & Data Group (RIDG)

The final quarterly meeting of 2024 was held on November 13 at MORPC. Members Langdon Sanders and Dr. Ayaz Hyder gave presentations on the topic of data privacy/security and the Columbus Community Information Exchange (CIE)

Staff suggested that the RIDG Steering Committee be dissolved at the end of the term of the current Ridge Steering Committee Chair, and have those participants engage directly with the RDAC going forward. This will result in RIDG functioning more like COGUG does, with staff engaging with RIDG members and RDAC members directly for future programming. An informal show of online and in-person hands indicated that members agreed with proposal – no opposition was noted.

#### **Future Drive Times Pilot Project**

To address one of the objectives of the Regional Data Agenda, modeling staff has taken a first step into projecting future drive times for trips originating in Delaware County and terminating in Franklin or Licking Counties in ten-year increments from 2025 thru 2050.

The work that was done incorporating the assumptions from our current metropolitan transportation plan, which documents the projects that are expected to be in place from now through 2050 and the resulting facilities and traffic congestion. The model is looking at current drive times for similar conditions and then assuming that when those conditions are met in 2050, what type of drive time there would be. One of the most important things learned was how manual and time intensive it was to do a handful of routes, but also potentially very valuable. Some routes show a 45% increase in round-trip travel time during weekday commutes.

Staff asked if RDAC and staff should explore the Drive times modeling project as a 2025 objective. An informal show of in-person and online hands indicated that no members were ready to take a position whether or not to pursue the project.

Staff asked if RDAC Members would like more information on this and think that it may be worth going forward. An informal show of in-person and online hands indicated that approximately half of the members would like more information.

Chair Drummond asked that there be more information and discussion on this topic at the RDAC Quarter 2 meeting.

#### Cybersecurity Working Group

Goal 5: SECURE & PROTECT -- Promote renewed focus on the security and resilience of systems and data through best practices and policy reviews with local governments and other stakeholders in the region.

<u>Quarterly Update Summary</u>: A total of 18 organizations were represented in-person at our "Cybersecurity for Local Leaders" event, and of those, five have submitted interest forms requesting to engage with the Working Group on their cyber efforts. Currently, no communities who were not physically present at the event have reached out to request assistance on the basis of the emails which were sent out to MORPC members.

<u>RDAC Discussion Item</u>: Apart from in-person events and email solicitations, what are some other options this group might leverage to generate additional interest among MORPC's member communities?

#### Updates:

- The individuals from the following communities / organizations have opted to engage with the RDAC Cybersecurity Working Group: City of Sunbury, Prairie Township, Ohio Chamber of Commerce, City of Columbus, and City of Dublin.
- Mark Bell, Working Group Member with Ohio Cyber Reserve, will conduct initial 30-minute meetings with all requestors beginning this month and report back to the group.
- The Working Group will be creating standardized "intake" and "impact" templates to help capture the outcomes of the Group's efforts as we move forward.

<u>Quarterly Update Summary</u>: The DEI & Data Working Group has submitted two proposals for DEI-centered presentations at Data Day 2025. For the immediate term, Working Group Members are solely focused on supporting group members preparing content around environmental justice analysis methods, and using data to lead successful transformation.

<u>RDAC Discussion Item</u>: Generating original content to engage with Central Ohio stakeholders is innovative and aligned with the Regional Data Agenda, but resource intensive. Apart from engaging audiences in professional development settings, what other venues or methods might the working group consider?

Updates:

- "Data for All" event was cancelled in favor of leveraging Data Day 2025 to reach the Group's target audience.
- Working Group Staff and Members Yan Liu and Hena Masood will lead Data Day sessions on analyses and data driven transformations.
- The Group will meet in January to provide support for presenters and discuss next steps for planned post-Data Day activities

<u>Quarterly Update Summary</u>: The Working Group plans to launch two distinct Office 365 lists, "Regional Data Coaches" and "Regional GIS Coaches" at Data Day, with sign-ups managed via a Microsoft Office form. The Group hosted a pop-up event at the Columbus Metropolitan Library on December 7. Members are currently developing outreach plans for 2025.

Updates:

- Following the discussions in the October RDAC meeting, the Working Group decided to manage two distinct Office 365 groups: "Regional Data Coaches" and "Regional GIS Coaches". The groups will be launched to all attendees on Data Day. To manage the signups for both coaches' groups, a Microsoft Office 365 form has been created. A QR code linking to this form will be distributed among Data Day attendees.
- The Working Group hosted their second pop-up event for community outreach at Columbus Metropolitan Library-main branch on December 7 from 10 -11.30 am. Members are working on outreach plans for 2025.

Workforce Tracking Working Group

Staff Lead: Adam Porr

Goal 3: SCALE & SUPPORT. Support a holistic approach to how the region captures and evaluates job quality data and equity gaps in the workforce system, empowering local governments and workforce boards to pursue coordinated strategies toward better employment outcomes.

<u>Quarterly Update Summary</u>: The Working Group selected five dimensions of job quality that we believe to be most pertinent to the region: earnings, schedules, safety & security, benefits, and learning & development. The Group identified several standards in each dimension to use to evaluate job quality, and we are currently working to fully define the most promising standard in each category. Those standards are living wage, predictability & advance notice, safety management system, employer compensation costs, and recruitment & support for disadvantaged populations. The Group is also wrapping up the planning/education phase of the Results for America Job Quality Fellowship and have been selected to participate in the sixmonth implementation phase starting in January. Kier Scott, Bob Gitter, and Courtney Thraen will attend a fellowship conference in Miami in February. Conference costs will be paid by attendees and fully reimbursed by Results for America Job Quality Fellowship.

Updates:

• The Group has experienced several changes in membership. The current roster is Bob Gitter (Ohio Wesleyan Univ), Jay Knox (OneColumbus), Bill LaFayette (Regionomics), Kier Scott (ASPYR), and Courtney Thraen (ASPYR), with staff leads/contacts Adam Porr and Padmini Roy-Dixon. Members Roy-Dixon and Thraen joined in December, and Randall Reames (X-Energy) resigned.
