






## **Metropolitan Planning Organization (MPO)**




A metropolitan planning organization (MPO)

- Federally mandated and federally funded transportation policy-making
- Created to ensure regional cooperation in transportation planning
- Urbanized areas over 50k per Federal-Aid Highway Act of 1962
- Federal funding for transportation projects and programs are channeled through this planning process
- Continuing, cooperative, and comprehensive ("3-C") planning process
- Statewide & MPO transportation planning processes are governed by federal law (23 U.S.C. §§ 134–135).
- Transparency (participation in planning process & electronic publication of plans)
   required by federal law



## **COMMUNITY ADVISORY COMMITTEE**



- Composed of members of the public
- Acts in an advisory capacity to MPO Board as liaison to the public
- Provides interaction and two-way communication between participants and staff about the planning process.
- Ensures that all plans and programs give consideration to possible social, economic, energy and environmental issues.
- Implements the Public Involvement Process relating to public participation and advise on public involvement strategies

# TRANSPORTATION ADVISORY COMMITTEE



- An advisory body to the MPO Board (Transportation Policy Committee) for transportation issues, primarily technical in nature
- Guides MPO technical work and develops recommendations on projects and programs for Transportation Policy Committee's consideration
- Usually composed of staff-level officials of local, state & federal agencies
- May have standing sub-committees, for example ATC, ITS
- May create ad hoc sub-committees

The 2024-2050 Metropolitan Transportation Plan (MTP) establishes a set of regional transportation goals and objectives and recommends strategies—including projects— that will maintain, manage, and develop Central Ohio's transportation system

through 2050.

## **REGIONAL GOALS**

By guiding investment in transportation and mobility infrastructure and services in Central Ohio, the MTP identifies strategies to advance the following six goals:



Create sustainable neighborhoods to improve all residents' quality of life.



Increase regional collaboration and employ innovative transportation solutions to maximize the return on public expenditures.



Position central Ohio to attract and retain economic opportunity to prosper as a region and compete globally.



Provide transportation and mobility to benefit the health, safety, and welfare of all people.



Protect natural resources and mitigate infrastructure vulnerabilities to maintain a healthy ecosystem and community.



Reduce per capita energy consumption and promote alternative fuel resources to increase affordability and resilience of regional energy supplies.





## FISCAL ANALYSIS - RESOURCES

- Assumes modest growth of current funding levels with some new funding in the region



- Prioritizes the actions for performance targets established in the MTP




## **TIP PROJECT MAP**

Identifies desired changes to the system (projects) within available resources	1	Projects <u>must</u> be in the MTP
Updated entirely every 4 years, rarely amended		Updated entirely every 2 years, amended quarterly or more often
