



MORPC ATTRIBUTABLE FUNDING



Update on Current Funding Round



- MORPC received commitment updates in July for all projects with an outstanding commitment of MORPC-attributable funding
 - Across 31 outstanding commitments, an additional \$23 million was requested
- MORPC received new requests for funding in September
 - \$52 million remained available to be allocated to new commitments
 - 20 final applications were received, requesting \$167 million
- The AFC recommends approval of the requested increases, as well as new funding commitments for 7 projects





ODOT SPECIAL ACTIVE TRANSPORTATION FUNDING

Beginning in October [2024], ODOT is offering a special solicitation for a variety of pedestrian or bicycle related projects, with an emphasis on projects that can be completed in the short term.

Who is Eligible?

 Any political subdivision, regardless of location inside or outside of an MPO.

Funding Details

- Funding will be available in FY 2025 and beyond.
- Applications can be submitted at any time, to be reviewed Quarterly (Jan 1, April 1, July 1, Oct 1).
- Most funding available at 100% (no local match)
 - Municipalities with >100,000 people must provide 20% match for infrastructure projects.
- This special solicitation is primarily offering reimbursement funding. Consultant assistance for planning or design are extremely limited.

What Types of Projects are Eligible?

- Non-infrastructures projects, such as:
 - Education and promotion projects, temporary demonstration projects
 - Data collection
 - Plans or studies like School Travel Plans or feasibility studies
- Infrastructure projects that can be built quickly (fully in the ROW, etc.):
 - Sidewalk replacement or trail resurfacing
 - Pavement markings
 - Median islands or raised crosswalks
- Traditional infrastructure projects of statewide significance, like:
 - Projects that improve the Level of Traffic Stress (LTS) of Ohio's State and US Bike Route System.

Central Ohio Greenways Progress Report

2024 PROGRESS SUMMARY

The region is entering an era of transformational trail building acceleration. Major accomplishments in 2024 include:

- regional collaboration resulting in over a quarter of the COG Vision within Franklin County funded for construction by 2030;
- the expansion of the COG Vision to 15 counties and identifying over 300 more proposed miles of trails for Vision expansion consideration;
- the launch of the Trail Town Working Group, whose success was recognized with the 2024 Regional Collaborative Achievement in Sustainability Award at the MORPC Summit on Sustainability;
- the completion three special projects including the COG Wayfinding Strategy, Detours & Closures Guidelines, and Mapping Natural Assets; and
- the launch of the Greenways Planning Studio (GPS), an effort to bring greenspace to the forefront of development in Central Ohio by identify pathways that bring innovative visions to reality.







Central Ohio Greenways Progress – Franklin County

LINKUS advances COG


- 189 miles of proposed COG trails in the COTA Service Area (CSA)
- 175 of these are eligible for TSI funding (i.e., within 3-miles of a fixed-route transit stop)
- 37 miles (20%) are in the 2025-2030 TSI CIP

MORPC AFC Advances COG

- 15 miles (8%) have received 2020 or 2022 Attributable Funding awards
 - 5 of these are also in the TSI CIP
- 5.3 miles are in outstanding 2024 applications (3.7-mi. overlap w/TSI)

COMBINED COG ADVANCEMENT

- TSI and past AF awards have funded 50 miles, or 26%, of the COG vision in the CSA for construction or project development by 2030.
 - 40 miles, or 21%, are specifically slated for construction by 2030
















Gateways of Regional Significance






Formal Safety Application

- Apps due March 31, 2025. Must be submitted to the District by March 3rd


Abbreviated Safety Application

- Apps due **March 31, 2025**. Must be submitted to the District by March 14th
- Future deadlines: June 30th, September 30th, and December 31st
- More information: <u>HSIP Abbreviated Safety Funding Application | Ohio Department of Transportation</u>

Systemic Safety Application

- Apps due March 31, 2025. Coordinate with District by February 14th if you plan to submit.
 - Must be submitted to District by March 14th
 - In addition to the project application and estimate, a map and/or concept of improvements are to be included.


