Central Ohio GIS User Group MID-OHIO REGIONAL PLANNING COMMISSION February 26th, 2025, 2:00 pm – 4:00 pm

1. Welcome/Introductions

We had almost 30 people in person and 30+ people on-line, with quite a few 1st timers. It felt like pre 2020 times. Thank you to all who attended.

2. Local GIS News

OGRIP update

OGRIP held a meeting a couple weeks ago that a few COGUG members attended. That meeting included references to ongoing projects and initiatives under the Ohio Geographically Referenced Information Program (OGRIP), with a focus on improving GIS data availability and accuracy across the state. Updates on the 3D depth data availability for South Central Ohio was highlighted. Talk of updating the state-wide city file that ODOT currently maintains as do many cities and counties. There are new LBRS specs and there was discussion on if they fully suit the 911 needs. Unclear if there will be another version or if DDTI will remap fields as needed.

ODOT update

ODOT staff reported that there were no significant new updates from the Ohio Department of Transportation at the time of the meeting but highlighted ongoing efforts to maintain and improve transportation GIS data.

County updates

Franklin County staff shared that the Franklin County 911 plan is expected to be approved soon, with a focus on enhancing emergency response systems through improved GIS data for addressing and routing. Staff also discussed the upcoming public meeting about the plan and its implications for GIS data usage in emergency management.

MORPC updates

Dave Dixon introduced a new email list serve designed to facilitate better communication among GIS professionals between COGUG meetings. This list, sponsored by the RDAC's Data Coaches Working Group, aims to help members share resources, ask questions, and provide support. The Data Coaches Working Group will hold a pop-up event in the next few weeks at the Parsons Branch of the Columbus Public Library, which will provide an opportunity for in-person discussion and support on various GIS and data topics. https://forms.office.com/r/brZ4rUCCP0

Bob explained the process of setting up a new city trees collection system, focusing on the integration between City Works and ArcGIS Online to manage urban forestry data efficiently.
