#### Sustainability Advisory Committee Meeting Notes

March 20, 2024, 2:30 pm

#### **Meeting Called to Order at 2:30 pm.**

#### **Welcome & Introductions**

Chair Kessler opened the meeting, introducing three new members, Council Member Christine Houk, City of Grove City, Carol Kauffman, Executive Director for Ohio Environmental Council, and Mayor Kenneth Wright, City of Westerville

William Murdock briefly welcomed Members, and congratulated the City of Columbus on being one of 25 cities nationwide selected by Bloomberg Philanthropies as one of 25 U.S. cities to join Bloomberg American Sustainable Cities.

#### **Regional Sustainability Programs & Priorities**

Staff's presentation highlighted the programs and priorities represented in MORPC's sustainability work. The presentation also covered the Regional Sustainability Agenda and the process for updating it, as one of SAC's 2024 priorities.

#### **Board and Working Group Reports**

##### Sustaining Scioto Board

Staff has been providing updates on the Regional Water Study, a 15-county study being funded by the Ohio Water Development authority. The Ohio EPA has been taking the lead and working in partnership with MORPC. Among other objectives, the Study will explore current and future water supply / demand to identify gaps, and will also include recommendations such as strategic locations for growth, potential regionalization of utility services, and innovative practices for water reuse and stormwater management. Hazen & Sawyer will be leading a consultant team to develop this study which is expected to conclude at the end of 2024. MORPC and Ohio EPA will be providing monthly virtual updates for members and stakeholders to stay engaged in the process.

##### Energy & Air Quality Working Group

*Climate Pollution Reduction Grant (CPRG)*: The MORPC team is continuing its work with City of Columbus and the rest of the core project team to lead regional planning and pollution mitigation actions. The regional efforts are informed by the CPRG Strategy Subcommittee (CSS), which met in February. The first deliverable of the planning grant was the Priority Climate Action Plan (PCAP) which was submitted by the March 1 deadline. The Columbus and MORPC teams are putting forward a proposal for the Phase 2 Implementation Grant that integrates key elements of the LinkUS W. Broad St. Mobility Corridor with the Regional Community Energy Strategy (ReCES), which will provide solar installations on publicly owned buildings throughout the 10-county Columbus MSA.

*Air Quality*: MORPC released the 2022-2023 End-of-Season Air Quality Report on March 4. Air quality was worse in the 2022-2023 season compared to the previous year, primarily due to the influence of external wildfire smoke. While there is some variation year-to-year due to weather

and external factors, overall, air quality continues to improve, and the region is in attainment with federal standards.

MORPC continues to move forward with the US EPA funded air monitoring project working in partnership with Franklin County Public Health. The team is collocating 40 PurpleAir sensors with Ohio EPA monitors to test and validate their performance before placing them in the community. MORPC hosted the Project Advisory Committee meeting on March 15.

#### Central Ohio Greenways Board – Mike Andrako

The COG Trail Towns Working Group will support the implementation of the COG Trail Town Framework, meeting every other month. The Working Group will be co-chaired by Kari Kaufman, Experience Columbus and Laura Ball, Westerville Parks & Recreation.

The Trail Development Working Group is chaired by Kelly Scocco, City of Columbus, and will also meet every other month. The Group will primarily focus on advancing the Regional Trail Vision. Goals for the year include expanding the vision to MORPC's full 15 county area, expanding trail plans to accommodate anticipated growth in the Intel area, and encouraging collaborative funding applications.

The Outdoor Trails Pass partnership with Experience Columbus was originally launched in 2020 and has been upgraded annually with new features every spring. There was a significant increase in the number of people interacting with and using the pass in 2023, primarily due to the inclusion of curated trail experience itineraries. This Spring the curated experiences will be enhanced through a partnership with local tourism groups. These new curated experiences will be highlighted in the 2024 Outdoor Trails Pass, launching on Celebrate Trails Day, April 27, 2024.

MORPC will convene the COG Trail Closure and Detours Steering Committee in the Spring to develop guidelines for managing and communicating trail closures and detours. The committee will meet monthly for six months.

The Designing Local consultant team is under contract to complete the COG Wayfinding Strategy. The team has met with stakeholders and has drafted a recommended signage strategy. They have also integrated Trail Towns, Public Art, and Placemaking concepts into the wayfinding strategy. The project is expected to conclude in the Spring of 2024.

MORPC will convene the COG Mapping Natural Assets Steering Committee this Spring. The group will advise the Mapping Natural Assets project funded by The Columbus Foundation to provide data to support holistic decision-making around how development impacts the sustainability of our region's watersheds.

MORPC will hosted a COG Forum on March 20 to share regional trail projects that go beyond infrastructure and focus on the trail user experience with enhanced amenities and placemaking.

MORPC and COG recently requested \$1.5 million through the federal Rebuilding American Infrastructure with Sustainability and Equity (RAISE) program for a trail planning and trail town project called Trail Towns in the Nation's Heartland.

**Central Ohio Greenways Board (Chair: Mike Andrako, P.E.)**

*Next meeting: March 27, 2024*

The COG Board met on January 24, 2024, to welcome new Board Members and review and approve updates to the Regional Trail Vision. Also on the agenda were MORPC program and COG Working Group Updates.

In 2024, the COG Trail Towns Working Group will support the implementation of the COG Trail Town Framework. The group will meet every other month and is co-chaired by Kari Kaufman, Experience Columbus and Laura Ball, Westerville Parks & Recreation.

The Trail Development Working Group is chaired by Kelly Scocco, City of Columbus, and will also meet every other month. The group will primarily focus on advancing the Regional Trail Vision. Goals for the year include expanding the vision to MORPC's full 15 county area, expanding trail plans to accommodate anticipated growth in the Intel area, and encouraging collaborative funding applications.

The Outdoor Trails Pass partnership with Experience Columbus was originally launched in 2020 and has been upgraded annually with new features every spring. In 2023, we saw a significant increase in the number of people interacting with and using the pass primarily due to the inclusion of curated trail experience itineraries. This Spring the curated experiences will be enhanced through a partnership with local tourism groups. These new curated experiences will be highlighted in the 2024 Outdoor Trails Pass, launching on Celebrate Trails Day, April 27, 2024.

MORPC will convene the COG Trail Closure and Detours Steering Committee in the Spring to develop guidelines for managing and communicating trail closures and detours. ## **Sustaining Scioto Board (Chair: Glenn Marzluf)**

*Next Meeting: April 24, 2024*

The Sustaining Scioto Board met on February 28. Board members were updated on the Farming for Clean Water project in the Upper Scioto watershed. The project focuses on developing a communication plan targeted at the agricultural and rural communities and aimed at increasing awareness of climate change impacts on water as well as increasing awareness and support for farmer and landowner adoption of water quality practices and public and private sector investments.

The MORPC team also provided updates on the Regional Water Study. The Ohio Water Development Authority is funding this 15-county study, with Ohio EPA taking the lead and working in partnership with MORPC. Among other objectives, the study will explore current and future water supply and demand to identify gaps. The study will also include recommendations such as strategic locations for growth, potential regionalization of utility services, and innovative practices for water reuse and stormwater management. Hazen and Sawyer will be leading a consultant team to develop this study which is expected to conclude at the end of 2024. MORPC and Ohio EPA will be providing monthly virtual updates for members and stakeholders to stay engaged in the process.
