**Meeting Called to Order at 1:00 pm.**

**Welcome & Introductions –**

Chair Christina Drummond opened the meeting, introducing two new members, Sam Filkins, Knox County Area Development Foundation, and Rick Wagner, City of Columbus. Members Filkins and Wagner each gave brief details of their background and current work.

William Murdock briefly welcomed Members, and praised staff on their recruitment efforts for RDAC, and the outcome of the State of the Region event on March 15.

**MORPC Updates**

Data Day 2024

Dave Dixon praised staff regarding Data Day, February 7. It was a very popular event, selling out two weeks before the day of. Dave asked Members for ideas for Data Day 2025 – sessions, speakers, venue.

**Working Group & User Group Discussion**

New Report/Discussion Process

Chair Drummond explained the new Working Group / User Group reporting process. For the April 1 meeting and in the future, staff will complete written report prior to each meeting for review by RDAC Members. This will enable Members to make better use of meeting time, discussing and sharing knowledge at the meetings. Members will share guidance and direction to staff at this time.

### Cybersecurity Working Group

Dave reported that:

- The Group will be assembling documentation from state, higher education, and federal agencies around cybersecurity best practices, programs, and services.
- The next meeting will be April 17 to consider how to compile the information into a singular document and presentation best suited for educating local government stakeholders.

Members made suggestions / comments:

- Small organizations have less funding, staffing, and experience than larger organizations. This is where the most assistance is needed.
- Solicit information from Members who already have a strong cybersecurity program.
- Cybersecurity relates to staffing and general standardization of architecture.
- Education for staff is the easiest way to increase cybersecurity.
- Chair Drummond suggested having a badging system for MORPC members in the cybersecurity arena, similar to Sustainable2050 – Silver / Gold / Platinum certifications.
- The Ohio Township Association and the Ohio Municipal League both have cybersecurity training available to members. MORPC may want to work with those two entities.

### Data Day Working Group

Jonathan Miller reported that:

- Data Day 2024 was held on February 7.
- Post-event survey showed very positive feedback on the event -- Respondents rated the event at a 4.3 out of 5.
- Areas of improvement identified were:
  - Larger event space with easier access
  - More networking opportunities
  - Afternoon coffee and expanded refreshments
  - More descriptions on the sessions and speakers on the hard copy programs
- The Data Day Working Group has begun planning for Data Day 2025, currently looking for a different venue and brainstorming potential themes.

Members suggestions / comments:

- Successful use cases for AI – session suggestion
- A session could highlight the ripple effect of what data brings to organizations.
- A display or session about things to celebrate thru data.

### DEI & Data Working Group

Dave reported that:

- The DEI & Data Working Group met March 14 to begin outlining the key aspects of a proposed DEI & Data workshop for later this year. Group Members will present rubrics recommended to facilitate what is expected to be a wide range of stakeholders and types of data sets.
- The Working Group will meet again on April 25.

Dave asked Members for comments / suggestions regarding the proposed Workshop.

Members suggestions / comments:

- How to get access to quality data
- How to evaluate data
- A data maturity model is needed

### Regional Data Coaches Working Group

Raj Roy reported the outcomes of three recent meetings:

- Unconference Session at Data Day (Feb 7) -- 12 attendees with good discussions.
- March 7 & March 28 Meetings
  - Review of S.M.A.R.T. goal
  - Reviewed user groups survey/interest forms to recruit people based on subject matter expertise, skills, methods, and tools.
  - Identified priority tasks:
    - evaluating platform options
    - defining role of advisors
    - recruiting advisors from MORPC network

Members agreed with Raj Roy's request to change the name of the group to Regional Data Coaching and to have Coaching Advisors and Coaching Members.

Potential Launching Platforms – Slack was suggested. Members noted that the volume of requests and what the engagement is meant to be may drive platform choice.

Raj noted that the official launch of the project will be on Data Day 2025, with COGUG and RIDG piloting and marketing the project prior to Data Day 2025.

### Workforce & Job Quality Working Group

Adam Porr reported that the Group:

- Is engaging with local organizations to improve understanding of regional context for job quality (results due July 31).
- Is developing a comprehensive job quality evaluation rubric (due October 31).
- Held an Unconference Session at Data Day, with vigorous discussion among approximately fifteen participants around refining the scope of the job quality evaluation rubric.

Adam asked Members for stakeholder contacts in the public, non-profit, academia, and private sectors who are currently working on workforce data. The goal is to work with employers at the beginning of this project so it will be used.

### Central Ohio GIS User Group (COGUG)

Cheri Mansperger reported that COGUG met on February 21 with 55 attendees. Presentations were from OGRIP, ODOT, the City of Hilliard, the City of Columbus, Adam Porr, and Burgess & Niple. The Group will meet again on May 15.

### Regional Information & Data Group (RIDG)

Ethan Hug reported that

- RIDG met on March 6, with presentations related to housing.
- RIDG Steering Committee will meet April 9, July 9, and October 8
- Full RIDG will meet May 29, August 14, and November 13.
- Preparations are underway for the second quarter 2024 RIDG meeting.

Staff asked Members to forward presentation ideas for the remainder of the 2024 RIDG meetings to Ethan Hug.

Goal 5: *SECURE & PROTECT -- Promote renewed focus on the security and resilience of systems and data through best practices and policy reviews with local governments and other stakeholders in the region.*

  - The group will be assembling documentation from state, higher education, and federal agencies around cybersecurity best practices, programs, and services.
  - Next meeting will be 4/17 to consider how to compile the information into a singular document and presentation best suited for educating local government stakeholders.

### Data Coaches Working Group

Goal 1: *CONVENE & COLLABORATE -- Foster value-added interactions among local governments and other stakeholders to enhance the use of data through robust sharing of best practices, analytics, and research in support of improved data-driven decision making in our region.*
