Meeting Called to Order at 1:00 pm.

Welcome & Introductions

Chair Drummond Megan Ash from ESC of Central Ohio and Lilly Tesfai from Franklin County Treasurer's Office.

MORPC Updates

Dave Dixon provided updates on MORPC recent activities and upcoming projects:

- **Cybersecurity Initiatives:** Dave discussed ongoing efforts to strengthen regional cybersecurity measures. He detailed the planning of an event aimed at educating local leaders about cybersecurity threats and best practices. The goal is to enhance the overall resilience of systems and data through collaboration with local governments and other stakeholders.
- **Data Day 2025 Preparations:** Dave reported on the progress in organizing Data Day 2025, an annual event focused on fostering value-added interactions among local governments and stakeholders to improve data-driven decision-making in the region. He mentioned venue scouting, particularly the potential use of Columbus State Community College's new conference facilities, and efforts to increase sponsorship participation to cover higher facility costs.
- **DEI & Data Workshops:** Updates were given on the Diversity, Equity, and Inclusion (DEI) & Data Working Group's plans to host workshops tailored for local government and nonprofit stakeholders. These workshops aim to help organizations implement more effective DEI strategies through better data management and benchmarking.
- **Regional Data Sharing and Analytics:** Dave discussed the expansion of regional data sharing initiatives that aim to enhance collaborative analytics and decision-making across various governmental and non-governmental entities within the region.

- Grant Opportunities and Collaborations: Dave also touched upon new grant opportunities that MORPC is pursuing to fund additional data-centric projects and the strategic partnerships being formed to leverage regional strengths in data analysis and policy-making.

Working Group & User Group Discussion

Cybersecurity Working Group

Dave Dixon discussed the finalization of the Working Group's Impact Statement and SMART Goals. The group is planning a cybersecurity event in the near future for local leaders to raise awareness and provide training resources.

Data Day Working Group

Jonathan Miller updated Members on the preparations for Data Day 2025, including venue considerations and sponsorship strategies. The Working Group recently attended a site visit at Columbus State Community College to assess suitability for the event.

DEI & Data Working Group

Dave Dixon outlined plans for an upcoming DEI & Data Workshop aimed at local government and nonprofit stakeholders. This workshop is part of MORPC's broader initiative to enhance the capacity of regional organizations in using data effectively to make informed decisions and policies that are inclusive and equitable. Discussions focused on workshop content, including sessions on resource accessibility, benchmarking DEI efforts, and managing sensitive data. The workshop is targeted to take place in the fall, hosted at the MORPC facilities.

Regional Data Coaches Working Group

Raj Roy reported on the evaluation of digital platforms to facilitate data coaching and knowledge sharing among members. The Working Group is considering platforms like Google Classroom and Confluence for organizing content and interactions.

Workforce & Job Quality Working Group

Adam Porr discussed ongoing efforts to assess job quality and equity gaps within the region. The Working Group is collaborating with Results for America to develop evaluation rubrics and identify relevant datasets.

Central Ohio GIS User Group

Cheri Mansperger highlighted recent user group meetings and collaborations with local and regional organizations. Updates included presentations on GIS applications and discussions on data management best practices.

Regional Information & Data Group

Ethan Hug provided an update on the Group's activities, focusing on data-driven decision-making processes. The Group is preparing for upcoming presentations on forecasting and regional data analysis.

Cybersecurity Working Group

Staff Lead: Dave Dixon

Goal 5: SECURE & PROTECT -- Promote renewed focus on the security and resilience of systems and data through best practices and policy reviews with local governments and other stakeholders in the region.

- Updates:
 - Met on July 8 to finalize proposed Working Group impact statement, next steps, and SMART goal
 - Continuing cybersecurity for local leaders event planning
- Impact Statement:
 - Curate federal and state cybersecurity programs, resources, and information. Make actionable information available to MORPC members to increase local governments' understanding of both cyber threats and available supports. Further engage MORPC Members to take advantage of existing state and federal cybersecurity resources, including assessment tools, training programs.
- Next Steps:
 - Collect and curate state and federal cybersecurity information, including current threats, available programs, resources and best practices.
 - Conduct MORPC Cybersecurity for Local Leaders Seminar, providing introduction to cybersecurity, threats/risks/impacts, and best practices programs/information/ resources available to them.
 - Encourage members to sign up for assistance conducting a cybersecurity self-assessment.
 - Evaluate the assessments and encourage engagement with available state and federal resources to improve cybersecurity.
- SMART Goal:
 - Complete collection and curation of information by July 31 and conduct Cybersecurity for Local Leaders Seminar by October 11 with more than 30 member organizations in attendance with more than 20 of those registering for a follow-up cyber security assessment.

Data Day Working Group

Staff Lead: Jonathan Miller

Goal 1: CONVENE & COLLABORATE -- Foster value-added interactions among local governments and other stakeholders to enhance the use of data through robust sharing of best practices, analytics, and research in support of improved data-driven decision making in our region.

- Updates:
 - The Data Day Working Group has continued planning for Data Day 2025
 - The Working Group attended a site visit to Columbus State Community College's new conference facilities to see if the space would be suitable for the event.
 - The facility has ample room for morning and lunch keynotes, as well as four potential options for breakout sessions.
 - Facility fees are reasonable

- The Group also discussed increasing the cost of attendance to offset the increased costs associated with a facility that has an increased capacity.
 - A robust sponsorship turnout will help alleviate the need for increased costs.
- A sponsorship package has been assembled by Amanda McEldowney with MORPC. The sponsorship package ranges from \$500 to \$5,000.
- The Working Group continues to work on the identification of a theme, potential entities to reach out for interest in sponsoring, potential tracks to focus on highlighting, and the identification of keynotes for the morning and lunch sessions.

Diversity, Equity & Inclusion / Data Working Group

Staff Lead: Dave Dixon

Goal 4: EXPAND & INCLUDE -- Identify barriers and provide solutions to improve inclusive and equitable data access across our region.

- Updates:
 - The DEI & Data Working Group met on June 14 to plan a DEI & Data workshop for local government and nonprofit stakeholders.
 - Targeting a two-hour in-person event this to be hosted at MORPC, this Fall.
 - Proposed workshop sessions:
 - “Overcoming Resource Constraints” - How can we help organizations reduce barriers or access additional resources needed to implement a data-driven approach to advancing their DEI objectives?
 - “Getting Started with Benchmarks” - How can we help organizations that are struggling to establish "appropriate" or "equitable" DEI benchmarks which are practical from data management and interpretability perspectives, yet still substantially capture their desired impacts?
 - “Operationalizing DEI Data to Reach Your North Star” - How can we help organizations incorporate data about how diverse communities or constituents impact and are impacted by their programs and services, to help those organizations realize their goal or realizing equitable outcomes for their target populations?
 - “Recruiting and Retention” - How can we help organizations to attract, retain, and advance a diverse talent pool through best practices in human resources, management, staff training, and partnerships with professional organizations, educational connections, and workforce development organizations to realize diversity and inclusion targets for their employees, committees, or governing boards?
 - “Sensitive Data Consumers and Users” - How can we raise awareness among organizations about known biases, blind spots, and the limitations of “found” data or administrative data which may impact the data's ability to appropriately inform decision making, and ultimately service to traditionally marginalized and underrepresented groups?

Regional Data Coaching Working Group

Staff Lead: Raj Roy

Goal 1: CONVENE & COLLABORATE -- Foster value-added interactions among local governments and other stakeholders to enhance the use of data through robust sharing of best practices, analytics, and research in support of improved data-driven decision making in our region.

- Updates:
 - A new member joined the Working Group. Welcome Joyce Ndege, Franklin County Data Center.
 - The Group is currently evaluating tools identified as potential platforms to service requests and provide data coaching. The identified tools are
 - Google Classroom
 - DokuWiki
 - Confluence
 - Nuclino
 - Reddit
 - To evaluate tools, the group is using base criteria such as ease of setup, low barriers to access, cost, and features like request categorization, customizable notifications, and data security.
 - On May 14, an email was sent to RDAC members, outlining subject matter expertise and service expectations. The purpose was to recruit potential 'Advisors' from the RDAC network. This same information was also shared with Data Day Attendees, Commission, COGUG, and RIDG. Only one volunteer so far!
 - Next Working Group meeting is on July 11.

Workforce Tracking Working Group

Staff Lead: Adam Porr

Goal 3: SCALE & SUPPORT. Support a holistic approach to how the region captures and evaluates job quality data and equity gaps in the workforce system, empowering local governments and workforce boards to pursue coordinated strategies toward better employment outcomes.

- Current Tasks:
 - Complete a data landscape survey to identify candidate datasets to inform assessments of job quality.
 - Participate in [Results for America Workforce Fellowship](#) program (through end of December 2024)
 - Develop a comprehensive job quality evaluation rubric (due October 31).
 - Select and define facets of job quality
 - Establish one or more metrics for each facet.
 - Identifying the necessary data to support the metrics.
- Updates:
 - Met with Jess Valand (Director of Economic and Workforce Development, Results for America) and learned about job quality assessment resources available through that organization.
 - Working Group has been accepted into the [Results for America Workforce Fellowship program](#). The fellowship kicks off on July 17 and runs through the remainder of the year. This session is focused on learning, and there is an optional follow-up session focused

on implementation in 2025. The program will provide access to monthly [virtual training sessions and office hours with RfA staff](#), as well as engagement with regional peers, and access to [RfA resources](#). All benefits are provided at no cost.

 - Do you have metadata and appropriate tags for your public layers?
 - Are they the most current?
 - Are the file names and attribute field names user friendly?
 - A list was created that will be shared in separate document.
 - *Office 365 Bookings* – Langdon Sanders, City of Dublin
 - Office 365 as web client
 - New bookings link on the left
 - Bookings figures out times everyone can meet together
 - People can click on different dates and see availability; select date and then select time on that date
 - Can set how far out they can book you
 - Will email you when applicant selects time; will pop up on your calendar (can also create event on Google Calendar)
 - Personal (can delete yourself) vs Shared (IT has to delete these) booking page
 - Does not book room
 - Make sure calendar is up to date (it may schedule you for a time you're actually gone)

- *Web Content Transparency: Too Much or Not Enough* – Jason Gillow, Pickaway
 - What's your current office web-site situation?
 - Who are your clients?
 - What limits do you face in office on getting content out?
 - Is it enough or not enough?
 - What resources do you have on-hand?
 - Pickaway County GIS – website and AGOL site
 - Keep it simple.
- *Symbolize and Label Centerline Ranges* – Jason Miller, MECC, Plain Twp Fire
 - Labeling centerline address ranges to make it easier to validate data (he sent out a pdf with instructions and a layer file.).
 - Great way to qc your roadway data to better use it for 911 and geocoding.

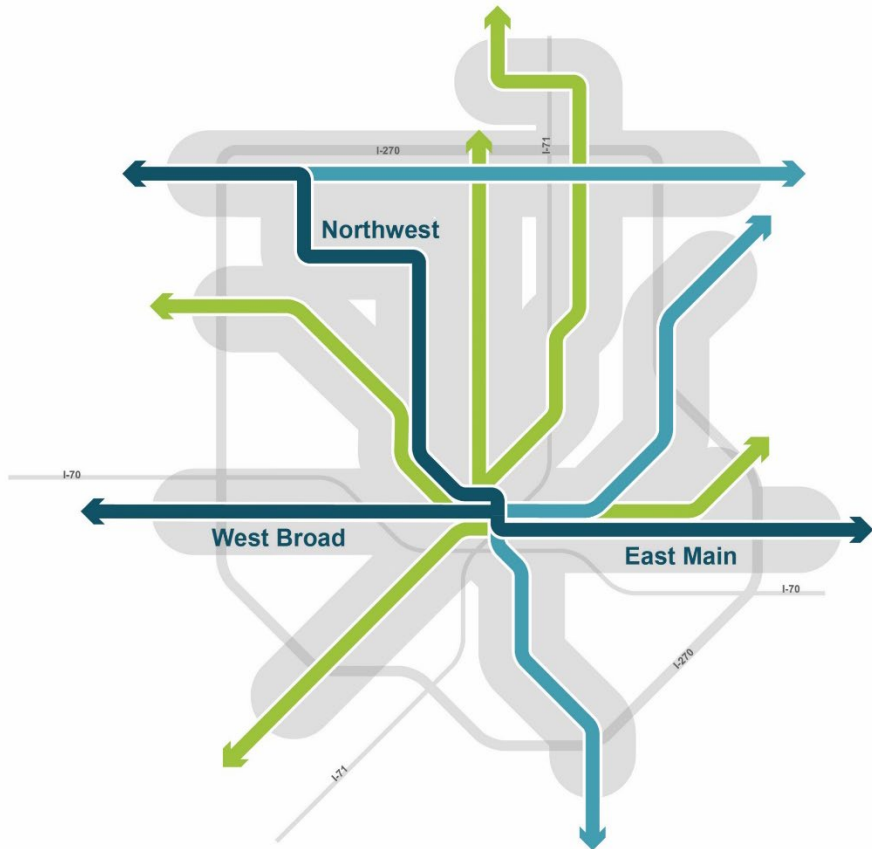

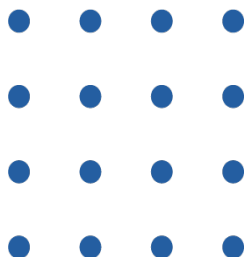

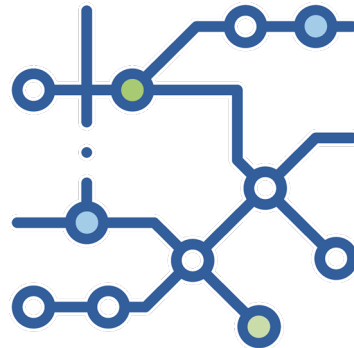
