#### Welcome & Introductions

William Murdock introduced Jessica Kuenzli, Chief Regional Planning Officer and Sr. Director of Planning and Matika Garrison Strategic Director of Technology

#### **MORPC Updates**

<u>MORE EVs (CFI) Grant Award / CURA-MORPC Housing Webinar Series / LinkUS</u> Dave Dixon highlighted the MORE EVs (CFI) Grant Award, which involves a \$15M federal award complemented by \$6.9M in regional investments for the installation of 406 EV charging ports aimed at enhancing mobility in underserved urban and rural communities. The discussion also covered upcoming initiatives like the CURA-MORPC Housing Webinar Series aimed at addressing regional housing issues, and the LINKUS project which focuses on improving public transportation through new rapid transit corridors.

#### Working Group & User Group Discussion

Cybersecurity Working Group

Dave Dixon prepared Members for the "Cybersecurity for Local Leaders" event, focusing on educating local leaders about cybersecurity threats and best practices.

#### Data Day Working Group

Jonathan Miller and Jordan Inskeep provided updates on the Data Day event, emphasizing collaboration among local governments and stakeholders to enhance data-driven decision-making. The focus was on the call for proposals and the efforts to secure sponsorships for the event.

#### DEI & Data Working Group

Dave Dixon discussed the DEI & Data Working Group's progress, including the challenges in planning the "Data for All" event aimed at enhancing inclusive and equitable data access across the region.

Raj Roy introduced the establishment of an Office 365 group to support data coaching, enhancing functionality and control for users which facilitates robust data-driven interactions.

#### Workforce & Job Quality Working Group

Adam Porr highlighted the Group's efforts in defining job quality metrics that support equitable employment outcomes, discussing initiatives like the participation in the Results for America Workforce Fellowship.

#### Central Ohio GIS User Group

Cheri Mansperger updated Members on recent GIS developments, emphasizing the sharing of best practices and innovations in data handling and usage.

#### Regional Information & Data Group

Ethan Hug noted ongoing efforts to integrate comprehensive data solutions across regional projects, enhancing overall data efficiency and accessibility.

#### Working Groups:

Data Day Working Group

Staff Lead: Jordan Inskeep

Goal 1: CONVENE & COLLABORATE -- Foster value-added interactions among local governments and other stakeholders to enhance the use of data through robust sharing of best practices, analytics, and research in support of improved data-driven decision making in our region.

- Updates:
  - The working group reviewed the Call for Proposals which was sent out to previous Data Day attendees and speakers, as well as COGUG and RIDG members.
  - Working Group members and Staff Liaisons continue to reach out to organizations regarding sponsorship. A package has been assembled by Amanda McEldowney with MORPC. The sponsorship package ranges from \$500 to \$5,000.

#### <u>Diversity, Equity & Inclusion / Data Working Group</u> *Goal 4: EXPAND & INCLUDE -- Identify barriers and provide solutions to improve inclusive and equitable data access across our region.*

- Updates:
- The working group met on Friday, September 13 to evaluate progress and identify support needed to complete content and assure alignment between proposed sessions for the "Data for All" event. All working group members have now been assigned sessions. The event is *tentatively* scheduled for mid-November and will be open to everyone.
- One member resigned from the working group due to a job change. The group may request additional time to reach their first milestone due to capacity for content and presentation creation.
- Question for RDAC:
- Last year's DEI Unconference at Data Day 2024 was well attended and well rated, but perhaps additional sessions/formats would be helpful. What would you recommend for Data Day 2025 to best continue the conversation?

#### Regional Data Coaches Working Group

Goal 1: CONVENE & COLLABORATE -- Foster value-added interactions among local governments and other stakeholders to enhance the use of data through robust sharing of best practices, analytics, and research in support of improved data-driven decision making in our region.

- Updates:
- The working group formed a Microsoft Office 365 group with support from MORPC IT to consider greater functionality and control for the user to support necessary data coaching needs. This group can receive and disperse emails from Internal and external members and can mimic the functionality of a LISTSERV. This will enable members to email questions and respond to the group with answers. This tool has some additional features for conversation control which is currently being tested by the D&M team and WG members.
- The working group hosted their first pop-up event for community outreach at Columbus Metropolitan Library-main branch on September 26 from 10 -11.30 am. The WG got good feedback from the attendees and plans to host another pop-up event this year.
- Next Working Group meeting will be held October 3.
- Question for RDAC:
- The WG is considering two distinct Office 365 groups separated out by GIS and non-GIS topics. What does RDAC think about this proposal and any recommendations for naming the groups?

#### Workforce Tracking Working Group

Staff Lead: Adam Porr

Goal 3: SCALE & SUPPORT. Support a holistic approach to how the region captures and evaluates job quality data and equity gaps in the workforce system, empowering local governments and workforce boards to pursue coordinated strategies toward better employment outcomes.

- Current Tasks:
- Participate in <u>Results for America Workforce Fellowship</u> program (through end of December 2024)
- Select and define dimensions of job quality for Central Ohio (done, tentatively)
- Identify and develop proposed job quality standards/metrics for dimensions
- Identify the necessary data to support the metrics.
- Updates:
- Two members resigned from the group due to other commitments (Thien Bui and Randall Reames). Current members include Bob Gitter, Jay Knox, Bill LaFayette, Adam Porr, and Kier Scott. Dave Dixon is also a frequent contributor.
- Working group representatives have attended the following events as part of the Results for America Workforce Fellowship:
  - "What is Job Quality?" (kickoff meeting)
  - "Procurement | Using Buying Power to Improve Job Quality"
  - "Policy | Advancing Job Quality through Administrative and Legislative Actions"
  - The group has selected several dimensions of job quality to prioritize, namely earnings, schedules, safety and security, benefits, and learning and development and is working to define strawman standards for each of these which are appropriate for the region.
- Questions for RDAC:

It occurs to our group members that measurement of some of the dimensions we've selected may require a survey or set of surveys of employers and/or employees. Do you think this is worth considering? Do you think employers would be willing to participate? After our strawman standards are complete, are there any individuals and/or organizations in particular that we should seek feedback from?

Cybersecurity Working Group

Staff Lead: Dave Dixon

Goal 5: SECURE & PROTECT -- Promote renewed focus on the security and resilience of systems and data through best practices and policy reviews with local governments and other stakeholders in the region.

- Updates:
- The working group continued developing a local leader oriented, educational event now titled "Cybersecurity for Local Leaders." Promotional materials and an event registration page have been created. The group met on Friday, September 20 to finalize the run-of-show, and coordinate member presentations.
- Cybersecurity for Local Leaders is a member only event where local government officials and representatives will learn about issues and opportunities CyberOhio, Ohio Cyber Reserve, CISA, and the City of Worthington.
- The event will be held at MORPC on October 31st

  - Can set how far out they can book you
  - Will email you when applicant selects time; will pop up on your calendar (can also create event on Google Calendar)
  - Personal (can delete yourself) vs Shared (IT has to delete these) booking page
  - Does not book room
  - Make sure calendar is up to date (it may schedule you for a time you're actually gone)



  - Additional 50 curbside ports in City of Columbus




